1. Apologies for Absence

1.1 Apologies had been received from Andy Brazil, Fraser Bowe, Ruth Goodall, Paul Rudkin, David Hissey, Mike Edwards, Bethan Edmunds, Niall Pettitt and Jason Moorse.

2. Chair's Announcements

2.1 The Chair thanked those members who were retiring from the NLAF; Andy Brazil, Vic Cocker, Bethan Edmunds, Mike Edwards, David Hissey, Suzanne Longe, Louise Rout and Paul Rudkin. He also welcomed the new members that were at the meeting today as observers; Rob Lodge, Karen Davison, Paul Baker, Birgit Griem, Rebecca Durant, Sarah Morgan and Anne Killett.

3. Minutes

- 3.1 The minutes of the meeting held on 6 October 2021 were confirmed as a true record.
- 3.2 The vice chair added that it would be useful for everyone to have notes of the informal meeting that had been held on 26 January 2022 and they are included as an appendix to these minutes.

4. Declarations of Interest

4.1 There were no interests declared.

5. Urgent Business

5.1 There was no urgent business.

6. Public Question Time

6.1 No public questions were received.

7. Local member Issues / Questions

7.1 There were no member questions received.

8. Feedback from Events

8.1 The vice chair reported that a note regarding the events attended had been circulated. He highlighted that the Suffolk LAF had met, and the next meeting was on 28th April which he would not be able to attend. He noted that the Broads LAF who met in March had a presentation from the Water, Mills and Marshes project which may be of particular interest to the NLAF.

9. Meetings Forward Plan

- 9.1 The NLAF received the annexed report which outlined agenda items for the forthcoming meetings.
- 9.2 The Chair reminded NLAF members to put forward further agenda items for consideration at any point either by contacting him, the vice chair, or the officers.
- 9.3 The NLAF **NOTED** the Forward plan.

10. NLAF Subgroups' report (Permissive Access; PROW; NAIP; Vision and Ideas; Joint Communications)

10.1 The NLAF received the annexed reports which set out the latest discussions and recommendations of the sub-groups of the NLAF.

10.2 <u>Permissive</u>

The chair of the subgroup reported that it had been a very frustrating 6-12 months. They had written to Ministers, Members of Parliaments and DEFRA about bringing back permissive paths into the Environment Land Management Schemes project but had received very little response and therefore he had no further update. The subgroup had been disbanded for the time being but if any matters arose, they could be discussed as part of the other subgroups.

10.3 <u>Public Rights of Way (PROW)</u>

The chair of the subgroup highlighted the following points.

- The subgroup was disappointed that although the NLAF had generated some points for consideration in response to the consultation around the Transport Asset Management Plan, the points had not been transmitted into the process. This had since been followed up with officers, but the points had not made a difference so far. The chair of the subgroup was exploring the possibility of taking them forward in some way. It wasn't clear how topics and comments discussed by NLAF were reported into the main council system, and he suggested that there needed to be a mechanism of how the minutes of the NLAF filtered into other the wider system. It was suggested that the Infrastructure and Development Select Committee could receive the minutes of the NLAF as part of the NAIP report twice yearly.
- A planning application affecting East Winch footpath 2 had been reviewed and noting that NCC had made lengthy comments, the NLAF were in support of the NCC response and therefore didn't feel an additional response was necessary
- Officers within NCC had reported steadily increasing numbers of Definitive Map Modification Orders (DMMO), and had an increase in staffing resources however, the level of applications were still outstripping the staff allocated to deal with it. It was agreed that an update would be brought to the next meeting regarding the DMMO applications.
- The NLAF's comments on the LTP4 Implementation Plan consultation would be submitted.

10.4 Norfolk Access Improvement Plan (NAIP)

The last meeting had taken place in March. The NLAF noted that the work that had been done around achieving the NAIP had been tremendous.

10.5 <u>Vision and Ideas</u>

The Chair of the subgroup reported that the last meeting was held in January. The group had been seeking a way to extract value from the network, especially the ordinary footpath network as it needed to be thought of as an asset rather than a liability where costs always needed to be cut. The NLAF had recently received a report from the subgroup which showed that the economic and health benefits outweighed the costs of maintaining the network. The County Council had several future initiatives ongoing which would provide funding for the networks and secure the future of the network. This report would be circulated again for the benefit of the new members. The chair of the subgroup was standing down as a member of the NLAF and therefore the NLAF would need to find a new Chair for the group. In the interim the Chair of the NLAF would stand in as chair of the subgroup.

10.6 The NLAF

- i. NOTED the PROW minutes from 4th April 2022
- ii. **ADOPTED** the title Community Access Warden by the NLAF to label parish volunteers
- iii. **SUPPORTED** NCC's position regarding a planning application affecting East Winch FP2
- iv. **AGREED** to ask NCC for its plan for dealing with increasing numbers of DMMO applications and to request an update at the next meeting
- v. **AGREED** to invite NLAF members to write to their MPs regarding the lack of public access in emerging government programmes such as ELMS, referencing a list of concerns
- vi. NOTED NAIP monitoring report (October 2021 to March 2022) and subgroup

minutes from meeting on 10th March 2022

vii. **NOTED** that officers would explore potential for NLAF minutes to be received by the I and D Select Committee twice a year with the NAIP report.

11. Pathmakers Projects

- 11.1 The NLAF received the annexed report which updated the Forum on the activities of Pathmakers.
- 11.2 Pleased to report that an events manager had been appointed for the walking festival for the NCC Platinum Jubilee Celebrations. The walking festival would be aimed at those who don't normally walk either through disabilities or socio-economic background. There would also be some funding associated with this.
- 11.3 The NLAF **NOTED** the report.

12. Protected Landscapes and Farming in Protected Landscapes (FiPL)

- 12.1 The NLAF received the annexed report and presentation which outlined the Norfolk Coast partnership response to the Glover review and Government recommendations. The report also explained the Defra funded Farming in Protected Landscapes (FIPL) program.
- 12.2 In response to a question regarding the level of confidence that ELMS and other land management schemes would provide funding if the Government does not, Officers explained that it was a case of not how much money was given, but how that was used and how opportunities were taken advantage of to deliver the aims. There was a high profile around diversity, equality and inclusion and a lot of the initial and pilot phases of schemes had a lot of emphasis on this. The Landscape Recovery ELMS pilot in Norfolk did include 30 evaluation points on innovative approaches to access in the countryside (which could be used for upgrading existing routes).
- 12.3 Members of the Forum were concerned that the wider ELMS scheme (once finalised) might not include restoring access. Officers confirmed that this was currently the case unfortunately.
- 12.4 With the FiPL scheme, landowners within the Norfolk Coast AONB (Area of Outstanding Natural Beauty) could apply for funding for projects that met the criteria, and access was a main focus for this year's funding. Forum members were invited to spread the word about the scheme to encourage local funding applications. More detail here https://www.norfolkcoastaonb.org.uk/
- 12.5 Members highlighted that the previous permissive paths schemes (funded through the previous Countryside Stewardship scheme) were short lived but had been hugely successful. When the scheme ended, people were upset about the closure of their local permissive paths. Landowners had tried to retain the paths to help local tourism, but without ongoing payment for maintenance etc. there was not enough incentive to do so. There was therefore concern that this program would again be successful but too short and would disappoint a lot of people once again when it finished.

12.6 The NLAF **NOTED**

13. Countryside Access Arrangements update

- 13.1 The Forum received the annexed report which highlighted this work in terms of the volumes of customer queries received and responded to. The paper highlighted the work in terms of the volumes of customer queries received and responded to. The paper also highlighted other key areas of work.
- 13.2 The Senior Trails Officer highlighted that some of the schemes in the report had been success in receiving additional funding through Natural England meaning that some schemes were predominantly funded externally.
- 13.3 The Forum acknowledged the work that had been carried out through the various projects, and how much it had changed the access of the networks for individuals.
- 13.4 The NLAF **NOTED** the progress made to date since the Countryside Access Officer posts were introduced.

14. NCC Member Sustainable Transport update

- 14.1 The Forum received the annexed report which provided a summary of the key walking and cycling projects relevant to the Local Access Forum.
- 14.2 The lead project Officer reported as an update that with reference to point 2.2, NCC had been successful in October 2021 in getting some funding from Department for Transport Capability fund which would help deliver a Norfolk-wide Local Walking and Cycling Infrastructure Plan (LCWIP). This would deliver a mapping of all the key priority active travel routes across Norfolk and would provide a prioritised list of infrastructure improvement for the short, medium and long term. As part of this there would also be a report which would cover the different stages of the delivery of the plan and would provide the local context. Due to having the list of improvements, that would help with applying for future funding such as Active Travel Funding which was due to be set up later in the year. They were already working with Countryside Access Officers to identify the prioritised routes and had reviewed all the neighbourhood plans that had been submitted and were also working with District Councils. Through the plan, engagement had started and there had been positive press regarding the plan. Officers confirmed that the Dereham LCWIP was in an advanced stage of development and would be included as part of the Norfolk LCWIP document due to be completed by the end of the year.
- 14.3 The NLAF **NOTED** the progress of the walking and cycling projects as outlined in the report.

15. Major Infrastructure Projects and Planning

- 15.1 The Forum received the annexed report which updated them on the major infrastructure projects that were currently underway in the County which impacted on Public Rights of Way.
- 15.2 The NLAF **NOTED** the table of major infrastructure projects in Norfolk.

1. Welcome and introductions

ALL present introduced themselves.

KH noted that it was regrettable that no formal decisions could be made as the virtual meeting was not in public. Covid restrictions had led to NCC cancelling the formal in-person meeting meaning that the meeting could only comprise updates and progress reports.

The NLAF did however have a mechanism to deal with consultations between meetings, which would be used to progress actions

2. Events attended.

KH had written a report to update the Forum on recent other Local Access Forum meetings. The report can be accessed on SharePoint <u>here</u>. ALL were encouraged to read it.

KH had observed that there was a general thread throughout, concerning a lack of information or clarity regarding Environmental Land Management Scheme (ELMS) payments for creating new public access (permissive access).

SF urged each NLAF member to write independently to their local MP to highlight the issue. This view was supported by KH and VC. KH recommended that letters highlighted the opportunity to improve on the previous scheme (Countryside Stewardship payments), where some landowners offered paths that suited their own needs, but there was no necessity to create access that joined up with other paths or offered benefit to local communities.

Cllr LH offered to raise the issue at the next NCC Sustainable Transport group meeting.

SW to follow up with Nicola LeDain on an invitee to the next NLAF meeting from Defra to talk on ELMS.

ALL to write to their MP to highlight the lack of funding through ELMS for permissive access.

LH to raise the same issue at Sustainable Transport mtg

MH pointed out that the Farming in Protected Landscapes (FiPL) scheme does involve an access element and NCC was involved in a pilot involving landowners in the Norfolk Coast AONB

KH reported a new mapping tool available from Natural England for mapping areas of open access

Informal updates from Subgroup Chairs and Pathmakers Permissive Access Subgroup – no update. Notes from meeting with Cllr Aquarone here.

<u>Vision and Ideas Subgroup</u>. VC had met with John Jones and MH in October to clarify spend by NCC on Public Rights of Way (PROW) in Norfolk (notes <u>here</u>). MH agreed to attend the April NLAF meeting to expand on the Greenways to Greenspaces NCC initiative to align public access and nature recovery (top down approach and longterm plan).

NAIP subgroup

The group had not met recently. SW to set up meeting for members which would include NLAF discussion on Statement of Action Objectives not started

<u>Communications subgroup</u> – no update. Group in need of a Chair: NLAF members were invited to register interest with SW.

Pathmakers CIO

SF said that Pathmakers is working on Geovation phase 2 (further development of a walking app with GoJauntly), HLF funding for a communications plan (update to come to NLAF in April); UEA Environmental Sciences undergraduate projects; a walking festival as part of the Jubilee events (but taking place later than June).

PROW subgroup

Notes from the meeting are <u>here</u> and report <u>here</u>.

Additional informal meetings to be arranged at 6 monthly intervals between the NLAF Chair and Vice Chair and NCC staff will allow exploration of topics such as enforcement.

2026 deadline: the group will put a formal request to NCC at the earliest opportunity to advocate for a 5 year extension to the deadline for registration for lost paths. NCC Councillors were asked to take note.

SW was asked to check currency of membership of all subgroups, chairs, terms of reference etc, for the July meeting.

4. Informal update Norfolk Trails / Countryside Access

RW provided an update on work on Norfolk Trails, ranging from installation of a new footpath at Roydon Fen with Norfolk Wildlife Trust; repairs to steps on the Paston Way; issues fixed at Gorleston to repair the National Trail; repairs to FP7 at Cromer; CIL funding for improvements at Rockland FP6 to link to community facilities; preparations for Kett's Country Trail, a new long distance trail over 18 miles (including circulars) between Wymondham and Norwich (but all on existing ROW); improvements to Marriott's Way including surface and gradient improvements, tree work, heritage interpretation; improvements to the Bure Valley Path funded through Interreg (Experience) and CIL; improvements at Brancaster FP9 and Thornham FP3. Presentation available to view here.

ALL thanked RW for his update and all the work ongoing.

KG said he was keen to follow up on NAIP actions to improve mental health and wellbeing through countryside access.

MW said that it would be good to ensure good linkage between access and other NCC initiatives such as Bus Back Better to help deprived areas in Norwich connect with new access opportunities. RW said there were good initiatives ongoing to improve signage from Milecross to the Marriott's Way which would help.

MH mentioned extension of the Beryl bike scheme to improve access to the Marriott's Way.

MH, MW, RW to meet to discuss further.

PC asked about links with Public Health team: RW and MH confirmed they worked closely with them.

VC had ongoing concerns over the boardwalk at Cley and a diversion at Holme. RW explained that the Cley boardwalk was not an NCC initiative (Environment Agency) but would be open once the safety audit was completed. The diversion at Holme was necessary to accommodate ecological survey work, and used the nearest ROW possible.

KH invited all to read the Countryside Access Arrangements report <u>here</u>.

5. NCC Environment Team and NSIPs update

MH updated the meeting on all the various initiatives ongoing through the Greenways to Greenspaces project including a new Norwich cycle map which includes the location of Beryl Bikes; active travel fund and e cycle extension fund which will make electric bikes available for hire at Wymondham and Drayton.

NSIP update given, including deadlines for various stages of the major projects including onshore windfarm cabling, road schemes etc.

PC asked how the NLAF developed responses to NSIP consultations (such as the windfarm cabling) as she would not wish to put her individual name against a response. KH said that responses were developed with the whole NLAF to ensure they represented what the membership felt.

6. <u>Reaching Young People</u>

NP introduced the topic of raising awareness amongst young people of the benefits of engaging with the outdoors. Just 45% of young people are as active as they should be – and the pandemic has made this worse, leading to long-term challenges around mental health. There are many reasons which contribute to this, including a lack of access to funds for transport to get to green spaces. Norfolk is in the bottom 3 of English counties for activity (Sport England report).

NP asked members to consider where the focus of effort would lie with engaging with young people (with the NLAF or NCC or other)?

KH said that the NLAF wanted to ensure that responses provided to any consultation would include the views of young people (amongst all the other groups whose interests are represented on the NLAF).

KG and MW felt that a subgroup could be setup to engage directly with young people to ensure the NLAF represents them fairly.

NP to scope out best mechanisms to engage with young people, with NLAF members

Report title:	NLAF subgroups' report (PRoW; NAIP; Vision and Ideas);
Date of meeting:	6 th July 2022

Summary

The NAIP subgroup and Vision and Ideas subgroup did not meet during the reporting period (since the April NLAF meeting), so this report concerns the PRoW subgroup only.

Recommendations for the NLAF:

PRoW subgroup

To consider the recommendations made in the Minutes of the PRoW subgroup meeting of 23 June 2022 (Appendix 1 and summarised below).

Two of the three recommendations made seek additional resources. The PRoW subgroup is fully aware that NCC is under continuing and increasing pressure to reduce its expenditure. Nevertheless, these recommendations are made

- 1 because they involve statutory duties, where lack of resource is not an acceptable reason for failure to undertake the duty, and
- 2 because the lack of resource is putting at risk the achievement of other well recognised policies (eg the Norfolk Access Improvement Plan) and aspirations (to provide the infrastructure needed to enable people to pursue their own health and well being)

NLAF has in the recent past produced a report using NCC's own data which shows that the limited expenditure on public access provides returns many times greater both in economic terms (spending by people using the access network) and health (the improvement of health and prevention of illness, physical and mental, that access to the countryside brings). The public rights of way network gives people that access, often directly from their doorsteps.

Recommendations – see 3 recommendations from the PRoW subgroup below

	Recommendations	
1.1	.1 7.1.1 NLAF should express concern to NCC that it seemed inevitable that statutory obligations regarding rights of way maintenance were not being met; arguably more importantly, the state of the rights of way network was preventing people from securing the health and well being benefits of access to the countryside.	
	Evidence : The report made to the subgroup (and in this agenda to NLAF) states (2.4, 2.5): "the Mayrise system of logged requests for service had at 16th June 2022, 1473 open issues for Public Rights of Way (continues to increase) Most enquiries received continue to be regarding damaged or missing signs, non-reinstatement, obstructions, overgrown surface, overgrown hedges/ trees and surface condition. The rise in cases is primarily attributed to the impact of Covid 19. While the country went into lockdown Central Government advice was that local outdoor exercise was promoted for wellbeing and there was evidence of significant increases in walking, running and cycling on village/local path	

	networks across the Country. There were also isolated cases of landowners using Covid as an excuse to close some paths. Naturally, additional use has led to an increase in complaints about the condition of the local path network. There remain considerable backlogs to work through. This has been recognised within the ROW profession nationally and some LA's are now re-evaluating the importance of adequately maintaining local path networks and several Eastern Region Councils have recently reported increases in staff numbers and maintenance budgets. Anecdotal evidence suggests that the increased use of local networks continues with people having formed new habits of getting outdoor exercise."
1.2	7.2.3 NLAF should request that NCC be asked to investigate whether its reporting system was providing timely and accurate information to those reporting issues.
	Evidence : NCC encourages reporting of issues to be made through its online system, and NLAF has several times supported this and tried to encourage path users acting as NCC's 'eyes on the ground' to use this system, recognising it as a vital part of the reactive system that NCC has established. NLAF also recognises the many improvements made to the system over recent years. It has therefore been disturbing to receive a report that a significant problem which was reported allegedly received an acknowledgement but no more, while a second report (by a different person but concerning the same problem) received a reply which apparently failed to note that there was already a report of the issue and was therefore inappropriate. Public faith in the system was low a few years ago, and it would be regrettable (to say the least) if that situation were to recur.
1.3	8.2 NLAF should request that NCC be asked to increase the staffing responsible for work on Definitive Map Modification Orders (DMMOs) in order to ensure that rights of way are not permanently lost to the county merely because of a lack of allocated resource.
	Evidence : Detailed evidence is recorded in 8.2 of the PRoW subgroup minutes. In summary, it is clear that the number of applications for DMMOs has predictably increased in recent years (as forecast and reported by NLAF on a number of previous occasions), and it is anticipated that this trend will continue. There are statutory duties here regarding timescales and actions, but even more important is the potential loss of rights of way in the county either for a lengthy period of time waiting for Orders to be made and decided, or permanently where user evidence is not available as some or all of the users have died, moved away or no longer able/willing to give that evidence.

Appendix

Kate Ashbrook, member of the Stakeholder Group which drew up the proposals incorporated in the Deregulation Act, has written this update for Walkers are Welcome.

The February announcement by Defra, that it would scrap the 2026 deadline for recording historic paths in England, was a significant step forward. In May Defra told the stakeholder working group (SWG) on rights of way that it proposes to proceed with the remaining statutory instruments not related to the cut-off, so that the full package of reforms originally envisaged under the Deregulation Act 2015 can be brought into force.

This is complex work and the SWG will be involved over the next few months in looking at the detail of regulations and guidance, the aim being to speed up and simplify the process for determining applications to add paths to the definitive map and statement.

But it's not all good news. Among these measures (but not part of the original package agreed by the SWG) is the introduction of the landowner's right to apply for path changes. This provision requires the highway authority to process such applications to a tight timetable, for which it will charge the applicant. This will result in many more applications for path changes on grounds of alleged 'privacy and security no doubt to the detriment of the public. While the law is unchanged, and the tests in the Highways Act 1980 must still be met, we know that the provisions in section 119 (for diversions) are already weighted against the public interest.

Moreover, this will skew highway authorities' work, requiring them to prioritise landowner-interest diversions when they should be focusing their ever-diminishing resources on removing obstructions, maintaining the network, and processing definitive map applications—all of which are in the public interest.

The user groups will endeavour to minimise the damaging effects of these proposed changes.

Executive summary

At the July 2017 Local Access Forum (NLAF), it was agreed that at each future meeting, a summary of the work the Countryside Access Officers and Environment teams would be provided. At the October 2017 NLAF it was agreed that this report should be presented to the PROW sub-group prior to being brought to NLAF.

This paper highlights this work in terms of the volumes of customer queries received and responded to. The paper also highlights other key areas of work.

Recommendations:

1. That the Local Access Forum note the progress made to date since the Countryside Access Officer posts were introduced.

1. Introduction

1.1. Since 1 April 2017, there is a single point of contact within each Highways Area office being responsible for their local rights of way issues. By having the officer within the Area office, they are more "on the ground" and better placed to deal with the operational reactive issues that occur when managing rights of way. They are supported by the wider Highways Area team staff. In addition, the Norfolk Trails team sits within the Environment Service at County Hall and carries out strategic and developmental aspects of developing the countryside access network.

2. Performance

- 2.1. The information in **Appendix 1** summarises the performance information available for the complete months since the last report.
- 2.2. The CRM defect reporting system went live in March 2018. Defect notes are being made visible to the public in the automatic update emails sent when third party defects have been inspected & more status options available on tablets under the 'No Defect' category, as previously reported.

Minor updates continue to be made to CRM to enhance operation and feedback elements.

The provision of additional information appears to have led to a decrease in follow up requests.

- 2.3. A new report has been prepared to display the relevant PROW/Trails information via PowerBI **Appendix 1 (a) and (b) (Stats for the last 3 months and 2 years).**
- 2.4. In summary, the Mayrise system of logged requests for service had at 16th June 2022, 1,473 open issues for Public Rights of Way (continues to increase). This reflects that PROW issues are often complicated matters to resolve. Most enquiries received continue to be regarding damaged or missing signs, non-reinstatement, obstructions, overgrown surface, overgrown hedges/ trees and surface condition.

- 2.5. The rise in cases is primarily attributed to the impact of Covid 19. While the country went into lockdown Central Government advice was that local outdoor exercise was promoted for wellbeing and there was evidence of significant increases in walking, running and cycling on village/local path networks across the Country. There were also isolated cases of landowners using Covid as an excuse to close some paths. Naturally, additional use has led to an increase in complaints about the condition of the local path network. There remain considerable backlogs to work through. This has been recognised within the ROW profession nationally and some LA's are now re-evaluating the importance of adequately maintaining local path networks and several Eastern Region Councils have recently reported increases in staff numbers and maintenance budgets. Anecdotal evidence suggests that the increased use of local networks continues with people having formed new habits of getting outdoor exercise.
- 2.6. At the current time there are no additional financial resources earmarked for PROW maintenance. 3 x PROW Technicians commenced their roles in September 2021, one each in support of Countryside Access Officer for the three highway areas. One staff member has subsequently transferred to a Trails role leaving a vacancy in North Area. This was filled again and commenced April 2022.
- 2.7. As of the 16th June 2022, the Norfolk Trails Team had 177 open CRM issues. Highways had 207 open CRM issues (both showing a slight increase)
- 2.8. These figures do not reflect the substantial volume of reports and correspondence still received through direct email and telephone communication from members of the public, but which remain unrecorded. Neither does it reflect the complexity often found in resolving PROW issues.
- 2.9. In addition to the numbers above, there have been a number of enforcement notices sent out to landowners since April 2022. The figures include more informal email conversations where the landowner is politely reminded that enforcement may follow if action is not forthcoming. The following have been issued:
 - 42 Section 131A,134-137 Non-reinstatement Notices/emails issued since 1 April 2022. The majority are resolved without recourse to further enforcement. It should be noted that there are significant resource pressures associated with serving and following up on Notices.
 - To date in 2022 since April 1st, 0x Section 130's (obstructions) and 3x s56 (out of repair) notices have been received by NCC
- 2.10. It should be noted that processing any legal notices is time consuming for NCC staff. Similarly, when NCC receives FOI requests, these are a drain on limited resources.
- 2.11. In terms of other progress, key highlights include:
 - Higher incidences of people using local paths during Covid and continuing through 2021 and into 2022. Also the wet winter 20/21 saw an increase in flooding reports and associated bridge damage. These issues are still being worked through, Bridges Team have a substantial backlog of missing structures, with most of the structures being timber there is a constant requirement to replace on a cyclic basis. Approximately 20 larger scale structures were replaced on the network in 2021/2.
 - 2022 cutting: Additional funding has been allocated to complete 2 cuts on the selected PROW routes again for 2022. Trails routes receive 3 cuts. The first cut is well underway. A new contractor is to be trialled in West Norfolk following issues with successive contractors in this area. He is facing some difficulties mainly in relation to the knock on effects of paths that missed out on cutting in previous years leading to heavier growth. Fuel price increases is making contracts less viable and we are anticipating increased costs in this

area going forward. Some Parishes have expressed an interest in carrying out their own cutting with financial support from NCC (equivalent to the amount spent under the main contracts) but this only currently applies to a handful of parishes.

- Enforcement procedures were carried out on a path at Upwell in 2021 removing gates but the landowner replaced them immediately. Further enforcement took place in March 2022. Police presence was required to allow enforcement to take place and obstructions were removed. These have been replaced once again. The matter is now with NPLaw
- The £15k "Urban paths" allocation was made for 2021/2 on a resurfacing project in North area at Brundall. The project was completed promptly and was well received. Projects for this year are now being considered.
- County Councillors have "Member Fund" to allocate to local projects each year, increased to £10k each for 2021/2 and this can be spent on small scale PROW projects of maintenance. To date, uptake on tackling PROW issues has been limited.
- Ramblers Association volunteers have organised and carried out some small scale works at Sustead using RA membership funds with overview from the North CAO. We would like to explore similar initiatives but more regular volunteer work may require support from NCC such as the purchase of material.
- Some large-scale landowner "rewilding" schemes are coming on stream and while these are good for the environment, are having potentially negative effects on the PROW network.

2.12. Norfolk Trails update



Executive Summary / Introduction from Cabinet Member

At the July 2019 LAF meeting it was agreed that the Walking and Cycling Champion provide a summary of the key walking and cycling projects relevant to the Local Access Forum. The Walking and Cycling Champion role has subsequently changed to Sustainable Travel Champion.

1.1 To provide an update to the Local Access Forum on progress on key projects from the Walking and Cycling Team.

2.1 Below is an update on key walking and cycling projects to be delivered in 2022

2.2 Norfolk Local Cycling and Waking Infrastructure Plan (LCWIP)

Following a successful bid to the Department for Transport's (DfT) Capability Fund the Cycling and Walking Team and currently completing a LCWIP across all of Norfolk. The outcomes of the plan will be:

- Mapping of priority Active Travel routes
- A prioritised list of infrastructure improvements in Short (1-2yr), Medium (3-5 yrs) and Long Term (5+ yrs)
- A report covering the details of the stages covered to develop the map and prioritised list

LCWIP's have been completed for Norwich, King's Lynn and Great Yarmouth and will the Norfolk LCWIP covering a lot of rural communities a specific focus will be on improved rural connectivity which includes our current PROW network.

We will be working with the Countryside Access Offers to gather feedback on priority community routes as well as reviewing Neighbourhood Plan.

Community engagement was undertaken between April and May 2022 and has gathered over 1,500 responses which has supported the network design process and an further network consultation on the proposed routes will be undertaken later this year.

Schemes that have been identified through the LCWIP process are more likely to get external funding so created a LCWIP covering all of Norfolk will put Norfolk County Council is a positive position for future Active Travel funding.

2.3 Active Travel Fund- Revenue Funding

Following the successful bid to the DfT we are continuing our revenue funding active travel promotion with the most significant development the piloting of school streets.

School streets is being piloted at 5 schools and managed by Sustrans

- Robert Kett Primary School
- Dussindale Primary School
- Browick Road Primary School
- Wensum Junior School
- Nelson Infant School

We are using volunteers to support staff the barriers and we will monitor the results of the pilots over the 18 month trail period.

2.4 E Cycle Extension Fund

The E Cycle Extension Fund looks to promote the use of e bikes as a sustainable form of transport. Through this fund we are working with Torque e bikes in North

Norfolk to provide discounted e bike hire.

We have also worked with Bike Register to provide discounted locks and bike marking kits to e bike retailers across Norfolk.

The E cycle Extension Fund will also fund the extension to the Beryl E Bike Network to Drayton and Wymondham, this is due to launch to early summer 2022.

2.5 Ketts Country Long Distance Trail Launch

Ketts County Long Distance Trail, the newest additional to the Norfolk Trails Network, launched in March 2022. The 18-mile route runs from Wymondham to Norwich and also includes 5 circular walks which were selected through community engagement to the project.

The route has new signage throughout and significant infrastructure improvements to improve accessibility across the route.

2.6 Wherryman's Way Access Improvements

Following a successful application to the Greater Norwich Growth Board Norfolk County Council has been awarded £216,500 from the Infrastructure Investment Fund for access improvements on the Wherryman's Way, working alongside the Broads Authority.

The project will create access improvements on the route through sections at Surlingham, Bramerton and Hardley Flood allowing improved all ability access. Improvements will include Bank Stabilisation at Surlingham, Bramerton and Hardley Flood, the installation of Bridges at Hardley Flood, the upgrading of footpaths, the restoration of the Bird Hide on Hardley Flood and improvements to the moorings at Rockland Staithe.

The project has started with initial project meetings underway, the dredging of the river Chet has been completed by the Broads Authority and the dredged material is being monitored prior to footpath restoration. The Project will run until the end of 2023.
