#### 1 Election of Chairman

1.1 Christopher Kemp was elected as Chairman for the forthcoming year.

#### 2 Election of Vice-Chairman

2.1 Michael Horsbrugh was elected as Vice-Chairman for the forthcoming year.

#### 3 To receive apologies and details of any substitute members attending

3.1 Apologies were received from Mr D Bradford, Mr D Buck, Mrs A Claussen-Reynolds, Mr R Jewson, Mr D Raby, Revd C Read, Ms K Robinson Payne, and Ms V Thomas.

#### 4 Minutes

4.1 The minutes of the meeting held on 22<sup>nd</sup> April 2016 were **AGREED** by panel as an accurate record and signed by Chairman **subject to an amendment** to mention Tom Townsend by name in paragraph 6.5.

#### 5 Items of Urgent Business

- 5.1 None were declared.
- 5.2 During this item, a query was raised as to whether the co-option of members should be included as an item on the agenda; it was clarified that this is on schedule to be included on the agenda for the next Committee meeting.

#### 6 Declaration of Interests

6.1 None declared.

#### 7 Finance and Risk Report

- 7.1 The Committee received the report by the Executive Director of Community and Environmental Services which covered the final financial position and risk management for the Norfolk Records Committee in 2015/16 as at 31st March 2016.
- 7.2.1 Through discussion the following points were raised:
- 7.2.2 A query was raised regarding the ability to meet the next target income generation increase; the County Archivist gave information on steps being taken to secure income through talks with family history websites over licensing deals which would provide an annual payment funding stream.
- 7.2.3 The committee queried whether Lottery grants had been considered as a source of income. The County Archivist confirmed that the Norfolk Record Office was a partner in many bids which were being submitted which would act as a source of funding if successful, and gave information on these.
- 7.2.4 A query was raised regarding the impact of Brexit on the financial situation for the Norfolk Record Office. After discussion it was clarified that there were not thought to be any risks to the Norfolk Record Office and therefore nothing to be included on the Norfolk Record Office risk register.
- 7.3 The Committee:
  - **considered** the performance with the revenue budget and reserves and provisions for 2015/16
  - **considered** the management of risk for 2015/16
  - **noted** the proposed budget savings for 2016/17 and beyond

#### 8 Government Policy on Archives

- 8.1 The Committee received the report by the Executive Director of Community and Environmental Services giving background information on the development of a new Government policy on archives by The National Archives.
- 8.2.1 Through discussion the following points were raised:
- 8.2.2 The County Archivist clarified that the identified skills gap, which could be developed further to benefit the Archive service, was taking advantage of modern technology and use of data for discovery of archives.
- 8.2.3 A discussion was held about the loss of skilled Latinists in the field due to changes in training and requirements for archivists, and how this could be addressed. A point was raised regarding the importance of other skills such as the management of physical forms of documents, palaeography, Law French and Middle English as well as Latin. The Committee asked the County Archivist to monitor this situation to ensure ongoing access to the records.
- 8.2.4 A discussion was held regarding online Archive data; the data was available but needs to be in a more accessible format; National Archives are leading on the consultation of the new policy.
- 8.3 The Committee **NOTED** the report and supported the County Archivist in his outreach work.

#### 9 The Norfolk Archives and Heritage Development Foundation

- 9.1 The Committee received the report by the Executive Director for Community and Environmental Services giving information on the Norfolk Archives and Heritage Development Foundation, known as NORAH, and the next steps, now that it had been registered by the Charity Commission.
- 9.2.1 Through discussion the following points were raised:
- 9.2.2 The County Archivist clarified that this is a separate entity from the Norfolk Record Office, with its own constitution and charitable object.
- 9.2.3 A discussion was held over the membership of NORAH's committee; it was agreed that it would be beneficial to co-opt a limited number of Norfolk County Council Local Authority representatives. The trustees would have limited liability because of the structure of the charity. The Chairman of Norfolk Record Office was an exofficio member of 'NORAH'.
- 9.2.4 It was clarified that the membership could be extended outside of Norfolk. The Chairman asked for suggestions of potential trustees to be passed on to the County Archivist for consideration.

- 9.2.5 There was a suggestion to ask the Head of Customer Services whether NORAH's website could be included on the Norfolk County Council directory and District Council websites.
- 9.2.6 The County Archivist planned to look into a 'secretary of trustee's' role for Jonathon Draper and whether/how this would occur.
- 9.3.1 The Committee RESOLVED to:
- 9.3.2 **NOTE** the report
- 9.3.3 **REQUEST** further updates be brought to future meetings, and to be informed of the final membership of the charity. The annual fundraising strategy would be brought to Norfolk Records Committee each year
- 9.3.4 AGREE that the Chairman write a letter of appreciation to the Senior Archivist, Freda Wilkins-Jones.

#### **Executive Summary**

This report provides information on the activities of the Norfolk Record Office (NRO) and its performance against its service plan during the period between 1 April and 30 September 2016.

#### Proposal

The Norfolk Records Committee is asked to:

Consider performance against the 2016/1716 service plan and comment accordingly

Performance against Service Plan

- 1 Develop skills and realise educational benefits of using archives
- 1.1 The Norfolk Record Office aims to encourage the use of archives by groups of all ages and abilities.

Formal Education

- 1.2 The Norfolk Record Office Education and Outreach team have continued to provide a variety of workshops and talks for children during the last six months. These have included:
  - Local history workshops at Rackheath School and Kinsale Junior School
  - World War II workshops for pupils from Erpingham Primary School and Lakenham Primary School
  - Refuge Day worshops for children at the Forum
  - A Children's University Event at Sprowston High School
- 1.3 The Record Office held nine events for schools, along with one for home education

children. A total of 444 children attended these events

Lifelong Learners

- 1.4 There has been a wide variety of events over the last six months. These are detailed in the two *What's On* booklets covering this period, the most recent of which covers events from July to December 2016.
- 1.5 Highlights from the last six months include:
- 1.6 Seal Sock Sewing Bees have continued with the most recent group meeting including a session with the Senior Conservator showing how the seal socks are being used in the God's House Unlocked project.
- 1.7 Heritage Open Days. The NRO held three events:
  - Change Minds events where participants showed their work. This provided an opportunity for people from the Change Minds Cromer project to meet people from the first cohort based in Norwich. It also gave participants the opportunity to invite their families to see their work.
  - An Archival Ambulation around Norwich using copies of archive sources
  - An open day at the King's Lynn Borough Archive where over three hundred people came to view documents on display and talk with an archivist.

Over the same weekend, it ran a stall at the Great Yarmouth Maritime Festival which was visited by over 1000 people.

- 1.8 NRO Blogger. A second cohort was trained to research articles which can then be posted on the NRO Blog. Recent posts on the blog have included:
  - The travel diary of Rachel Sheringham
  - Alfred Albert Suggate: Loddon's musical maverick
- 1.9 An Introduction to Family History workshop run in partnership with the Norfolk Heritage Centre.
- 1.10 In total 52 talks and workshops were delivered to a total of 1,132 people

#### **Developing New Audiences and New Uses for the Collection**

#### Volunteer Programme

- 2.1 Volunteers have contributed 1277 hours to the NRO during this period. There are currently 18 regular volunteers.
- 2.2 As well as the longer running volunteer projects, such as the Horner map cleaning and the indexing of Marriage Licence Bonds, some of the other volunteer arctivities have

been:

- Detailed cataloguing of the correspondence of Captain Frederick Charteris and Lady Louisa Charteris, née Keppel, 1872-1905 (MC 3214) and Sir Robert Clayton's papers re the estate of William Cobbe at Sandringham, 1660-1679 (MC 2370).
- Introduction to the Archive Profession placements have been run for two people with an interest in pursuing a professional qualification. This runs for a week and enables them to get an idea of the variety of work in a busy local authority archive service.
- 2.5 A number of volunteers and work experience placements have now secured paid employment and training. One has recently started at the Rolls Royce archives; another has secured a temporary Archive Assistant post at the NRO and a third has used her experience to secure a place on the Aberystwyth University distance learning course.

#### Change Minds

2.6 Members of the first cohort of the Change Minds have completed their three terms on the course. This mental wellbeing course, which uses the records of St Andrew's Hospital, is a Heritage Lottery Funded partnership between the NRO, The Restoration Trust and Together in North Norfolk. An important element of the project is an evaluation of its wellbeing impact; this is being led by Dr Victoria Scaife from UEA. A draft report on the outcomes for the first cohort has been prepared and this shows an overall increase in the general wellbeing of the participants. As well as quantitative data collection, the evaluation forms allow participants to write their own comments. Some of those collected from the first year were:

Has been awesome!! Thank you 😳

I think the course and the outcome for everyone has been a fantastic help to all involved

Change Minds is brilliant

I have enjoyed change minds immensely. It has been a great success

The feedback is also being used to improve the course for the second Changes Minds cohort which started in September

2.7 There has also been another, shorter Change Minds course running over ten sessions in Cromer Library. This is being delivered by a partnership between the NRO, Norfolk Libraries and Norfolk Community Learning Services.

Changes to NRO: The Archive Centre

- 3.3 Internal building work has now been completed at the Archive Centre. This has resulted in:
  - 1. New office accommodation for the Registration Service.
  - 2. Removal of the reception desk near the Searchroom and its replacement with a reception desk at near the steps
  - 3. New visitor furniture and areas in the Long Gallery
  - 4. A new staff room on the first floor
  - 5. A new Glass Box between the Searchroom and the Green Room
  - 6. Moving the Sound Archive to the former listening room
- 3.4 The total cost to the Record Office of this work, including fees, is in the region of £20,000.

#### 4 Managing and Developing the NRO Collection

#### **Accessions**

4.1 A total of 168 accessions have been received during this period. The most significant of these are the records purchased as part of the Morningthorpe Manor Sale that account for one of these 168 accessions; these are the subject of a separate report. Some of the other highlights include:

4.2 A cataloguing template has been developed for use by depositors prior to the receipt of documents by the NRO. This will enable certain depositors to create lists ready for import into the NRO catalogue.

#### **Digital Preservation Consortium**

- 4.3 Work has now started with the project partners from Norfolk, Hertfordshire, Cambridgeshire and Peterborough on the digital preservation project. A contract has been signed with a third party supplier who is providing a hosted system for this work. This consists of a file transfer system linked to an Archivematica pipeline (a workbench for processing digital files) and an instance of ICA Atom (an archive description and management system)
- 4.4 All parties took part in a web based training session with the software developers in Canada and small, collaborative training sessions have been arranged between the project partners.
- 4.5 The aims of this pilot project are to assess the most efficient way of meeting our digital preservation needs whilst developing new skills and understanding
- 4.6 There is growing interested in this project and requests to visit the NRO have been received from Cameron Mackintosh Ltd, Jaguar Daimler Heritage Trust, the British Motor Industry Heritage Trust and the University of Westminster.

- 4.7 Following interviews in July, the third digital preservation traineeship (funded through the Heritage Lottery Fund Skills for the Future programme) will start in October. This digital preservation project will form the core of their work over the coming 12 months. The holder of the previous placement has now secured employment working on digital records at the National Theatre.
- 4.8 Whilst the tools being used in the consortium help with many of the issues surrounding the preservation of digital records, there are still areas which need work. One of these has been addressed by producing an advice sheet for depositors of digital records. This sets out the preferred file formats for the transfer of digital records to the NRO, the need to remove password protection and the background information we require to manage the records.

#### God's House Unlocked

- 4.9 The God's House Unlocked project, which is creating a full catalogue of the UNESCO World Heritage Register inscribed Great Hospital collection, has been running since April. During this period, 42 of the 52 boxes in NCR Case 24 have been catalogued. This represents 54% of the total. It includes the founder's will, cartulary, letters patents, general accounts, court rolls, bailiff's accounts, rentals, extents and records of litigation.
- 4.10 Throughout, old boxes and packaging have been replaced with new, archive standard materials. As a part of this, bespoke, specially designed archive boxes and internal packaging for the deeds and, in many cases, their pendant wax seals has also been made.
- 4.11 As a part of the engagement activities around this project, an intermediate palaeography course started at the NRO in September. This objective of this ten session course is to equip its participants with the skills to work on 15th century account rolls.
- 4.12 Some of the items catalogued are described in more detail in Appendix 2.

#### **Caring for the Collection**

- 5.1 A conservator has been recruited to cover the maternity leave of one of the conservation team. The new conservator, who started on 8 August, has 25 years' experience in conservation having worked at, what was then, the Public Record Office and the Tate. Meanwhile, the conservator for whom he is providing maternity leave cover, gave a paper at the Archives and Records Association conference demonstrating recent innovations in parchment humidification developed by NRO.
- 5.2 Work has been completed on all the King's Lynn items requiring digitisation. This included the charters and items for the exhibition. The conservation team also organized and supervised the return of the document to Lynn in order to minimize the risk of damage during the move.

- 5.3 Planned conservation work has been completed on:
  - 1. C/Sca 2/193: Martham enclosure award
  - 2. BEA 401, 439x2: Manor court book of Banyard, Lalfords and Butley
  - 3. MC 1811/23:Rental from the Norfolk Manors of Sir E. Bowyer Smyth
- 5.4 The Collection Care team have also secured two orders for large bespoke boxes: one for the History of Advertising Trust and another for a commercial supplier who has ordered 50 large costume boxes.
- 5.5 The Senior Conservator has also delivered two bookbinding sessions. One to the Change Minds group and another as a masterclass at the Town Hall in King's Lynn.
- 5.6 The Conservation team also continue to support the work of other teams. As well as providing access services for fragile documents ordered in the searchroom they have trained eleven people in Document Handling techniques and contributed to 31 tours of the building.

#### 6 King's Lynn Borough Archive

- 6.1 The conditions in the strongroom have now reached the environmental standards required for the storage of archive; this enabled the collection to be returned in September. This barcode system, put in place when the collection was moved to Norwich, was used again to create a location guide very soon after the documents had been returned.
- 6.2 The documents have been stored by size, rather than reference, which has made considerable space savings. There are also plans for further reorganization and packaging which will free up additional storage capacity. The means that the NRO will be able to stored additional documents in Lynn and it is currently identifying suitable collections to keep there. It is likely that priority will be given to archives which can be used for engagement activities and anticipated research projects.
- 6.3 The archivist at King's Lynn moved to another job in July and, since then, staff from Norwich have been covering the post. Shortly after receiving notice, an advertisement for the post was placed in the Archives and Record Association's *ARC Recruitment*. However, the Record Office was unable to make an appointment.
- 6.4 The Record Office has failed to make an appointment to this post before and readvertising carries the significant risk of failure that this will happen again. Therefore, to manage this risk, the Record Office plans to establish a traineeship in King's Lynn. The successful applicant will study for a professional qualification by distance learning and, upon successful completion of the course, will progress to the post of archivist in Lynn. Throughout the course, NRO staff will provide mentoring and support.

#### 7 Financial Implications

7.1 The implications for finance are set out in the section above and in the Finance Report presented to this committee.

#### 8 Issues, risks and innovation

8.1 Officers have considered all the implications which members should be aware of. Apart from those listed in the report (above), there are no other implications to take into account.

#### 9 Background

9.1 This report refers to the Norfolk Record Office Service Plan which was approved by the Norfolk Records Committee in April 2016.

## Appendix 2

### Some Highlights from the God's House Unlocked Cataloguing

Ref: NCR Case 24a/4

On the dorse side of an account of 1320, is a mid-13th century schedule of many Suffolk parishes, probably a taxation list compiled by diocesan officials and including references to pensions paid to the priors of several Suffolk and Norfolk priories and also to the chamberlain, almoner, hosteller of Bury St Edmund's Abbey.

NCR Case 24d/1/11

At the foot of the account of 1333, is a re-used parchment membrane recording lists of [? diocesan or hospital] officials and servants 'garconibus' in receipt of summer livery in rabbit furs and ells of burrell cloth from Northampton and 'Stanford' [Stamford], 1252.

#### NCR Case 24b/19

On the dorse side of 1444 memoranda are receipt and payment accounts for the one and a quarter years from Jan 1443-April 1444 of William Wyght, the under-sheriff for Suffolk. The receipt accounts list those amerced for exigencies and those paying for 'sueta', (their freedom from incarceration before trial). Payments concern assize proceedings and justices expenses among other things.

NCR Case 24b/22a-b

Agreements in English between Sir William Aleyn, the parson of Thwait and Sir Thomas Prentys, the parson of St 'Albertes' [Ethelbert's] Mundham, with the assent of the leading parishioners, apportioning, after a variance concerning liability for tithe payments between the two parsons, lands in the open fields of St Ethelbert's and St Peter's, Mundham and of Thwait, 1440-1444

#### NCR Case 24b/25

Agreement that Dr John Selot, clerk and master of the Hospital and its confraternity for £200 paid them hospital by the executors of Ralph Segryme and Richard Broun, formerly mayor and aldermen of the city (now dead) the master and fellows are forever obliged to provide one suitable, secular chaplain without benefice to say vespers and matins each day and mass every Sunday and feast days in the chapel for the honour of God and St Barbara, the comfort of prisoners, the good estate of the mayor and City and for the sake of the souls of Segryme, Broun, their wives and for those of John Wilby and his wife and for those of all benefactors of the chapel, the City providing a chalice, service books and vestments, 1472.

#### NCR Case 24b/36

Counterpart agreements for the keeping of the poor people in God's House between the Corporation and successive keepers of the Hospital, detailing their wages, allowances and duties, 1566-1686

#### NCR Case 24e/5/2

The Lathes in Norwich, John Dernell, carter's half-yearly account and journal entries in English, 1417 detailing the costs of daily cartloads of materials (muck, stone, gravel, clay, lime, sand, timber, furze and other fuels, crops, chaff among others), transported to and from the Hospital from estates around Norwich and Norfolk.

#### NCR Case 24e/5/11

The Lathes in Norwich, the 'journal' entries of John Boys, ploughman and carter, Nov 1428-Nov 1429, being an aid memoir in English to an agreement between Boys and Sir Geffre [Halle], 'styward of seyntt gylis ospital', describing each week's daily carting and ploughing work from St Andrew's Day [Tuesday 30 November 1428] to the week starting the 28 November 1429. The prices of loads of various materials (stone, clay, crops, timber, furze, whins and other fuels among others) are also given, along with references to bad weather when it disrupts work.

#### **Executive Summary**

This report provides an update on the Norfolk Archives and Heritage Development Foundation, known as NORAH, its recent fundraising and support for purchasing documents.

#### Proposal

The Norfolk Records Committee is asked to note the report and make comments or suggestions on how the charity's objectives might be furthered.

#### Introduction


1.1 At the last meeting the Records Committee received a report updating them on the progress of NROAH. At that stage it had recently received its Charity Commission registration.

#### Fundraising

- 2.1 In August the Record Office became aware that it needed to raise funds to support the purchase of documents at the Morningthorpe Manor Sale at Keys Auctioneers in Aylsham in September.
- 2.2 A calculation, based upon the auctioneer's estimates, indicated that a total of £30,000 would be required. Initially support was sought from charities and £5000 was secured from the Friends of the National Libraries. However, it soon became clear that a public appeal would also be required.
- 2.3 A case for support was developed providing a clear message of what was needed and why. this built on the training which Record Office staff had received through a National Archives programme to support fundraising.
- 2.4 However, before a campaign could be launched, it was essential that NORAH had a web presence. A specification for a website had been written and a full site was being developed, but this still required considerable development time; more than was

available. Therefore, a permanent url was registered (<u>www.norah-df.org.uk</u>) and used to host a simple, single-page, temporary website. This website was linked to a PayPal account, again as a temporary measure, to enable online giving.

- 2.5 The campaign was launched and publicised through a blog post, the NRO contacts database, its social media and the EDP.
- 2.6 By the time of the sale, NORAH had reached its funding target of £30,000 (£25,000 from NORAH) having raised £25,370. A breakdown of the size of donations is shown below.



2.8 Contributions were received from local groups, national charities and many individuals. The latter included donations from throughout England, from Scotland and one from New Zealand.

#### The Sale

2.7

- 3.1 NRO attended the sale on 8 and 9 September where it secured 91 lots (including five purchased for the Norfolk Heritage Centre and funded through NORAH) for a total of £30,387.
- 3.2 A full list of the lots purchased is included as Appendix 1. Of these the lots for which the hammer price was £500 or more were:
- 3.3 Walter Clutterbuck Photograph Album 1919, purchased for the Norfolk Heritage Centre (£600)
- 3.4 Four Stratton Strawless deeds, 1431-1468, 1508 and 1578, relating to the Marsham family with seals (£500)
- 3.5 Ten journals and diaries kept by Anthony Hamond, Thomas Astley, Horace Hamond and J A H Hamond 1872-1888, illustrating the workings of a medium

Norfolk estate (Westacre) (£550)

- 3.6 Great Hospital Norwich deeds and documents, late 17th century to early 21st century, circa 240 items, (£1250)
- 3.7 William Cubit and Richard Taylor: Proposed navigation of ships from Foundry Bridge, Norwich to the sea at opposite Lake Lothing, 1825 (£520)
- 3.8 Confirmation and patent book of the Dean and Chapter of Norwich Cathedral, 1621 -1675 (£6,800)
- 3.9 Map of land in manors of Whinburgh, Westfield and Carbrooke belonging to Sir William Clayton, 1735 (£1200)
- 3.10 Diaries and journal of Horatio William Walpole, Later 4th Earl of Orford 1826, 1831, 1836-39, 1848-50, 1853, 1860, 1863-65, 1868-72, 1882 and 1884 (£2600)

#### Post Sale

- 4.1 As well as being able to support the purchase of these documents, the campaign has been a great opportunity to launch NORAH,to make new contacts from Norfolk and beyond. It has made many new contacts from Norfolk and beyond. Some of these contacts have been with groups and individuals who outbid the Record Office for items, but with whom the Record Office is interested in working in the future.
- 4.2 The weeks following the sale have seen over 100 individual messages and letters sent out thanking the people and organizations for their donations. We are also in the process of registering NORAH with HMRC so that Gift Aid can be claimed on many of the donations.
- 4.3 The Record Office will be inviting people who made donations in to view the archives they helped purchase and is planning an exhibition in the Long Gallery to showcase many of the purchases.

#### 3 Financial Implications

3.1 The costs of the items purchased were fully covered by the funds raised by NORAH and the grant from the Friends of the National Libraries.

#### 4 Issues, risks and innovation

4.1 Officers have considered all the implications of which members should be aware of. Apart from those listed in the report (above), there are no other implications to take into account.

#### Strategic impact

This report covers the forecast financial position and risk management for the Norfolk Records Committee in 2016/17 as at 30<sup>th</sup> September 2016

#### **Executive summary**

This report covers the financial forecast for the Norfolk Record Office (NRO) budget outturns for 2016/17. Section 1 covers progress with the NRO revenue budget for 2016/17, reserves and provisions. Section 2 provides the Committee with an update on the service risk register.

The main issues for consideration by this Committee are:

• Progress with NRO Revenue budgets and Reserves and Provisions indicates that the service should achieve a break-even position at the year-end

• Progress with risk management for NRO.

**Recommendations:** The Norfolk Records Committee is asked to consider and comment on:

- Performance with the revenue budget and reserves and provisions for 2016/17
- Management of risk for 2016/17

#### 1. Revenue Budget

#### 1.1 Financial Performance 2016/17

1.1.1 At the end of 2016/17, the NRO expects to deliver an outturn balanced to budget. This is summarised in the table below.

1.1.4 The additional premises and supplies and services costs relate to: building works at the Archive Centre, the digital preservation project and purchases made at the Morningthorpe Manor Sale. These are expected to be covered by additional income the source of which is grants from the East of England Regional Archive Council and from the Norfolk Archives and Heritage Development Foundation and a slightly higher level of income generation than anticipated through digitization projects.

#### **1.2 Capital programme**

1.2.1 There is no capital programme for 2016/17.

#### **1.3 Reserves and Provisions**

- 1.3.1 The table summarising the 2016/17 position appears below.
  - The Residual Insurance reserve is planned to be used in the year to support project development and other income raising activities. This includes administrative support to the Norfolk Archives and Heritage Development Foundation and the development of joint funding applications.

#### 2. Risk Management

- 2.1 The service continues to manage the risks to its objectives both internal and external. The risk register is reviewed and updated on a quarterly basis and was last reported to this Committee at the last meeting. A summary of the risk register based on the most recent review of October 2016 appears at Appendix A.
- 2.2 The register contains five key risks, four of which are currently assessed as a 'medium' level risk, while one is assessed as 'low'.
- 2.3 All risks are being well managed. Two of the risks are showing 'Green on schedule' progress towards achieving their target risk scores, and the other three are showing 'Amber' and with further planning should be met.
- 2.4 The impact of the unmet risks on the budget has been assessed as follows:
- 2.4.1 For RM13959 'Loss of or reduction in funding', if this external funding was lost then the service would need to reduce spending in in line with the reduction of funding. This risk is classed as 'Amber' however additional income streams have been identified in 2016/17. The risk is mitigated by continuing to apply for external funding and explore income generating opportunities.
- 2.4.3 For RM13963 'Inability to continue collecting archives', an increased level of accessions would reduce the available space more quickly than planned. Records are kept of the amount of additions and available space and bespoke packaging is used to reduce the amount of space needed. There is also work which can be carried out to further increase the capacity of the King's Lynn strong room. This risk is classed as 'green' and is not expected to occur in 2016/17, and so will have no impact on the revenue position.
- 2.4.4 For RM14164 'Failure to meet growing public expectations on access', is the risk that the public can't access collections as easily as they expect to. This could mean demand for our services would reduce. This is mitigated through entering into commercial partnerships to improve access and planning for access to digital images in search room. Plans are in place to increase the amount of digital images available through commercial partnerships. This risk is classed as 'green' and is not expected to occur in 2016/17, and so will have no impact on the revenue position.
- 2.4.5 For RM14165 'Failure to collect, preserve and make accessible new formats of archive', NRO is not in a position to fully manage the preservation and continued accessibility of born digital records. This is mitigated through developing procedures, staff skills and exploring collaborative approaches. This risk is classed as 'Amber' however the NRO is now leading a collaborative regional project to address these issues.
- 2.4.6 For RM14167 'Collection at risk through unexpected events', due to the special nature of the NRO collection the usual NCC continuity planning has to be reviewed and adapted. This is mitigated through the roll out of specific Emergency Plan, in which all staff, including recent recruits, have been trained. This risk is classed as 'green' and is not expected to occur in 2016/17, and so will have no impact on the revenue position.

### 3. Financial Implications

The implications for resources including, financial, staff, property and IT, where relevant, are set out in Section 1 of this report.

#### 4. Issues, risks and innovation

Officers have considered all the implications which members should be aware of. Apart from those listed in the report (above), there are no other implications to take into account.
