## **Executive Summary**

This report sets out proposals to reduce the existing 30mph to 20mph speed limit along the length of Meadow Way, Hellesdon. The speed limit is being promoted due to the concerns about speeding traffic travelling along the road, particularly in the proximity of the pedestrian school gate onto Meadow Way. Implementation should improve safety for all pedestrians and cyclists including pupils and parents.

#### Recommendation:

1. To implement the 20mph speed limit as advertised on the plan in Appendix A and Traffic Regulation Order in Appendix C.

## 1. Background and Purpose

1.1 The local member and County Councillor Shelagh Gurney, and Hellesdon Parish Council raised concerns for the safety of children using Meadow Way when walking to Firside Junior School due to speeding traffic.

## 2. Proposal

2.1 The proposal seeks to implement a 20mph speed limit on Meadow Way between the C261 Reepham Road and A140 Cromer Road, including both the northern and southern sections of Meadow Close and was consulted on as per the drawing in Appendix A.

## 3. Impact of the Proposal

3.1 The 20mph speed restriction will assist in suppressing vehicle speeds and raise the level of road safety to improve safety for all highway users, particularly cyclists, pedestrians, parents, and pupils who attend the local school. The lower speed limit should also help sustainable transport by encouraging more cycling and walking.

#### 4. Evidence and Reasons for Decision

- 4.1 Shelagh Gurney County Councillor and Hellesdon Parish Council raised concerns regarding the safety of children using Meadow Way when walking to Firside School.
- 4.2 The proposal aims to reduce the speed of vehicles by reducing the speed limit to 20mph.
- 4.3 The advertised proposal received 6 objections which are summarised below. A redacted summary of the exchange from the start to the end of the engagement is included in Appendix B.

Objection Comments Received	Officer Comment
20mph speed limits are only effective if policed	Norfolk Constabulary do not police 20mph speed limit. Although a police presence to monitor the speeds may be possible.
Community speed watch measures would be more effective	This would be something that the parish council or local residents could consider.
More effective measures may be to block the road halfway along	This is not considered feasible, or affordable such provision would require turning heads for which there is not the space and would be costly. This solution would also force residents to use only one access/ egress route and affect through flow of traffic.
Build outs to be constructed rather than 20mph	The road layout should itself suppress vehicle speeds. While build outs are successful it would add significant furthers costs to the scheme and not felt to be required.

4.4 Support for the proposals was received from 16 residents whose comments are summarised below:

## **Support Comments Received**

The speed many cars travel along the straight stretch of road is concerning and dangerous manner, if something is not done soon someone will get injured.

With the proximity to the school pedestrian gate access many cars park on Meadow Way and so risks of accidents is increased by excessive speeding Meadow Way has a high footfall of young children, and the proposals will safeguard these vulnerable pedestrians

There are near misses on this road every day and so decreasing the speed limit will help immensely

## 5. Alternative Options

- 5.1 One alternative option is to not to implement the 20mph speed limit, which would mean pedestrian safety would not be improved, particularly adjacent to the school.
- 5.2 Another option would be to add build outs into the carriageway to slow vehicles. This is not felt necessary or feasible and would add significant costs to the scheme.
- 5.3 Community speed watch arrangements could also be considered. Hellesdon Parish Council have been made aware of this option for their future consideration, however this will only be in place when the speed watch is in operation.

## 6. Financial Implications

6.1 This Traffic Regulation Order and associated works are being funded by contributions from the Local Councillor's member budget allocation and Hellesdon Parish Council.

# Appendix B- Correspondence from Objectors Hellesdon Meadow Way 20mph speed limit/ TRO

## **Officer Comment**

## **Objector 1**

I object to the 20-mph speed limit on Meadow Way on two grounds: 1) 20 mph speed limits are only effective if Policed. Ours is a cut through and regular users will soon learn that our road is not Policed. 2) If we have a 20-mph speed limit we cannot have a community speed watch programme. These are effective. 3) Our road needs chicanes. These are proven to slow traffic and need no policing. Therefore, I would prefer chicanes and a community speed watch programme

Norfolk Constabulary do not police 20mph speed limit. Although a police presence to monitor the speeds may be possible. A community speed watch is something that the parish council or local residents could consider setting up

## **Objector 2**

With regard to the proposed speed limit, I would like to add my concerns. Who is going to police this rule? I suspect no one, just the same as the other local restrictions. My husband and I live at the crossroads with Windsor Road and are alarmed at the speed and the lack of 'give way ' or even stop at this junction. The speeding traffic commences at around 6.30 am and is really quite alarming. My idea is to stop this rat run as on Heath Crescent by blocking off the road on the main corner we have a wide section to accommodate this idea and stop these idiots. There will be a serious accident before long, as you may be aware all four properties (including ours ), on the corners have had vehicles crash through into the garden however the post should help with these incidents so let's stop the speeding! If my idea is not possible then maybe chicanes is the next best option. The 20mph signs will be a waste of money, I fear.

Norfolk Constabulary do not police 20mph speed limit. Although a police presence to monitor the speeds may be possible. Regarding blocking off the road This is not considered feasible, or affordable, such provision would require turning heads for which there is not the space and would be costly. This solution would also force residents to use only one access/ egress route and affect through flow of traffic

## **Objector 3**

I am a resident of meadow way, and we recently received a letter stating the plans for the new 20mph speed limit. It mentioned policing the limit and the police having time to enforce the limit. It also spoke about a chicane. I feel policing is a waste of everyone's money and resources and the same effect could be achieved in other ways. Using police to enforce a speed limit on a small road is a waste and they could be used else ware for bigger problems however i feel chicanes and an electric speed reader would have the same effect along with a few 20mph signs as well. However, this would in turn need advertising the changes and

possibly even more streetlights as imagine chicanes had been added and no one was aware and speeding during the night a large incident could occur. Meadow way is very poorly lit and hard to navigate at night-time. As well as the fact that the road is pretty small in the grand scheme of things, so these measures need to be properly planned to be most effective.

## **Objector 4**

Please reconsider the 20 mph restrictions that are being proposed. I along with many neighbours feel that this would not help the issue as there is no policing of this area. We have had and continue to have parking issues with the school traffic, which is never policed, and illegal parking occurs every day. So, because of this I feel that chicanes would be fit for purpose and a community speed watch would be much more effective than 20mph restrictions which will not be monitored. I appreciate the costing is high, but I feel it would be false economy and unproductive to do anything else.

## **Objector 5**

I have heard that the Council wish to introduce a speed restriction of 20 mph all along Meadow Way. I am not sure that a speed restriction would work if it is not properly policed, going to Drayton as often as we do and using Hall Lane, I find that the chicanes work far better as it stops people racing down the road. I appreciate that it will cost more, but at times when the children are come to or from the school, I have a fear one or more will get run over by motorists going too fast. I look forward to hearing what decision the Council arrives at.

## **Objector 6**

I fully agree that meadow way should have chicanes or at least speed bumps. A 20mph speed limit will not be enough to stop the speeding. I live on the corner of Meadow Way (alongside the footpath) and live in fear and dread that one day someone will be run over. it is an accident waiting to happen. i do hope you are successful in your survey.
