# 4 Members to Declare any Interests

Please indicate whether the interest is a personal one only or one which is prejudicial. A declaration of a personal interest should indicate the nature of the interest and the agenda item to which it relates. In the case of a personal interest, the member may speak and vote on the matter. Please note that if you are exempt from declaring a personal interest because it arises solely from your position on a body to which you were nominated by the County Council or a body exercising functions of a public nature (e.g. another local authority), you need only declare your interest if and when you intend to speak on a matter.

If a prejudicial interest is declared, the member should withdraw from the room whilst the matter is discussed unless members of the public are allowed to make representations, give evidence or answer questions about the matter, in which case you may attend the meeting for that purpose. You must immediately leave the room when you have finished or the meeting decides you have finished, if earlier. These declarations apply to all those members present, whether the member is part of the meeting, attending to speak as a local member on an item or simply observing the meeting from the public seating area.

#### 5 Exclusion of the Public

The committee is asked to consider excluding the public from the meeting under section 100A of the Local Government Act 1972 for consideration of the item below on the grounds that it involves the likely disclosure of exempt information as defined by paragraph 7C of Part 1 of Schedule 12A of the 1972 Act as extended by the Standards Committee (England) Regulations 2008, and that the public interest in maintaining the exemptions outweighs the public interest in disclosing the information.

The committee will be presented with the conclusion of the public interest test carried out by the report author and is recommended to confirm the exclusion.

If published, the release of the information could further impact on the

complainant who had reported this matter to the Monitoring Officer and could dissuade others from reporting alleged breaches of confidentiality.

4.3 The Chairman and Sub-Committee members, having duly considered whether to release this information, concurred with this view and it was:

The Sub-Committee agreed that agenda item 5 be excluded from public disclosure by virtue of paragraph 7C of Part 1 of Schedule 12A (as extended by the Standards Committee (England) Regulations 2008) to the Local Government Act 1972 and the tests applied above, confirming that the public interest in maintaining the exemption outweighed the public interest in disclosing the information.
