1. Apologies for Absence

1.1 Apologies were received from Cllr Julie Brociek-Coulton, Cllr Fabian Eagle and Russell Wilson.

2. Minutes of the last meeting

2.1 The minutes of the meeting held on 24 October 2018 were confirmed as a true record and signed by the Chair.

3. Declarations of Interest

3.1 There were no interests declared.

4. Urgent Business

4.1 The Chairman accepted two pieces of urgent business as they were time sensitive.

1) Proposed Diversion of the Brettenham Byway Open to All Traffic under Highways Act 1980 s116/117

The NLAF had a few concerns regarding this proposal, one being that the grid references were not correct and the type of proposed fencing that would be used. The Chairman suggested a site visit, and this would be organised with those who were interested after the meeting.

2) Greenways

The Chairman had attended an event for this. NLAF had raised in the consultation that it hadn't mentioned horse riders. It was confirmed by Officers that that it was key that the Greenways included use by horse riders as it was important to get horses off the road.

5. Public Question Time

5.1 No public questions were received.

The agenda order was amended as follows;

16. Coastal Access In Norfolk

- 16.1 The NLAF received the annexed report regarding the England Coast Path which is Natural England's responsibility for implementing.
- 16.2 The Forum heard from Diana Curtis via teleconference that Natural England were taking on board points regarding the consultation process and the report writing made by the NLAF regarding the consultation on the Coast Path between Hunstanton and Weybourne.
- 16.3 The NLAF felt that members of the public that were not represented by a statutory group were disenfranchised from the consultation and this was a flaw.
- 16.4 The NLAF agreed to invite Natural England to the next meeting of the NLAF in April.

6. Sub-Groups (Permissive Access, PROW, NAIP)

- 6.1 The NLAF received the report which summarised activities since the last NLAF meeting by the NLAF's three subgroups.
- 6.2 The NLAF expressed considerable disappointment at the response of the County Council regarding the Transport Management Plan.
- 6.3 Parish Councils should be engaged regrading permissive paths to increase user pressure.
- 6.4 It was also suggested that a working group would be set up and that it was discussed at the next meeting along with the new 'visions and ideas' subgroup.

6.5 The Forum **RESOLVED**:

- (i) that the NLAF considers a proposal from the PROW subgroup to set up a working group to explore the value of the PROW network to Norfolk (health, economy etc.)
- (ii) that details of a new permissive access scheme developed in Bradenham are noted and promoted by the NLAF.
- (iii) that the NLAF endorses the NAIP which has now been completed with timely and helpful assistance from the NAIP subgroup.

7. NLAF Annual Report

- 7.1 The NLAF received the annexed report which outlined the annual report of its activities.
- 7.2 The NLAF **AGREED** the report.

8. Pathmakers Update

- 8.1. The NLAF received the report which provided them with an update on the work of Pathmakers since the last NLAF meeting.
- 8.2 The NLAF **NOTED** the update from Pathmakers and offered support for their ongoing work.

9. NLAF Recruitment Update

- 9.1 The NLAF received the annexed report which outlined the recruitment process that the NLAF were undertaking.
- 9.2 There was a short discussion about the requirement to include skills suitable for Pathmakers into the NLAF specification. After putting it to the vote, it was AGREED that it should be included.
- 9.3 The NLAF NOTED progress to recruit and review membership of the Norfolk Local Access Forum.

10. Proposals to set up an NLAF Communications Subgroup

- 10.1 The NLAF expressed concerns about the rebranding of the NLAF to become Pathmakers as they felt they were separate bodies. It was suggested that Pathmakers needed to be independent and not be blurred through the identity of the NLAF. However, they could have the same communications group.
- 10.2 A communications strategy could be written on a page of A4 and Geoff Doggett offered to put something together to make a start.

10.3 The NLAF **AGREED**:

- (i) set up a communications group which will operate for Pathmakers and the NLAF;
- (ii) identify NLAF members and Pathmakers trustees who would sit on the new

communications group to develop a joint communications plan;

11. Countryside Access Arrangements

- 11.1 The NLAF received the report which summarised the work undertaken by the Countryside Access Officers and Environment teams. It highlighted the work in terms of customer queries received and responded to. The paper also highlighted other areas of work.
- 11.2 The Area Manager reported that 'Fix my Street' was being used frequently instead of the Norfolk County Council application when reporting problems with public rights of way etc. This required the data to be manipulated in order for it to be put into the CRM which added extra work.
- 11.3 The Forum heard that there was disparity of variances in the report which had to be managed. One of the causes was the that districts were unevenly distributed with public rights of way, the south-east having the greatest number and more smaller public rights of way.
- 11.4 The NLAF **NOTED** the progress made to date since the Countryside Access Officer posts were introduced.

12. Major Infrastructure Projects

- 12.1 The NLAF received the report which identified the major infrastructure projects planned in Norfolk, their current status and their implications for the Public Rights of Way.
- 12.2 The NLAF suggested that the public rights of way (PROW) sub-group could be a better forum for detailed discussion about the infrastructure projects.
- 12.3 The NLAF suggested that there should be a written protocol for response to the consultations. This was AGREED by the Forum and taken forward.
- 12.4 Comments made by NCC to planning applications were available on the Planning Inspectorate website and the relevant planning authority website.
- 12.5 The NLAF **NOTED** PROW implications associated with current major infrastructure projects and plans and requests a protocol (and sufficient detail) from NCC Environment Team to allow the NLAF to make timely comments on projects.

13. Norfolk Access Improvement Plan (NAIP) signoff)

- 13.1 The NLAF received the annexed report which requested the NLAF to sign off the NAIP. The NAIP replaced the Rights of Way Improvement Plan 2007-2017.
- 13.2 Thanks were expressed to the NAIP sub-group and Officers who had worked on the NAIP.

13.3 It was hoped that the NAIP would now be publicised appropriately and the Communications department would be approached.

13.4 The NLAF **AGREED**;

- (i) To sign off the plan and recommend to the EDT Committee approval of the plan.
- (ii) To thank the members of the NAIP subgroup for their involvement with production of the plan;
- (ii) That the NAIP subgroup would become a monitoring group for the Statement of Actions and Annual Delivery Plan

14. Greenways Project

- 14.1 The NLAF received the annexed report which updated on the Recycling Norfolk's Disused railways, now known as the Greenways Project. There was also an update on the public consultation on the pilot route proposals.
- 14.2 The NLAF heard that as part of the feasibility study, access was being reviewed. It was agreed that horses needed to leave the highways, and hopefully the project would incorporate either bridleway or restricted byway if the width allowed.
- 14.3 The consultation had been well received and the proposals had met people's expectations. As part of the consultation, other routes were being looked at. £350k had been agreed for this financial year and the same had recently been agreed for the following year.
- 14.4 The heritage along the routes had been included as part of the feasibility studies.

 Officers were in touch with heritage organisations and it was hoped to replicate what had been achieved along Marriott's Way and Weavers Way.
- 14.5 There was huge support for the project and it would be possible to leave the possibility open for rail use at some point in the future.
- 14.6 The NLAF **NOTED** opportunities presented in the feasibility studies (Weavers' Way Aylsham to Stalham; King's Lynn to Fakenham; King's Lynn to Hunstanton) and feasibility review of the whole disused railway network across Norfolk.

15. Green Infrastructure Team Introductions

- 15.1 The NLAF received the annexed report which outlined the two new roles that had been developed at NCC. The Officers were present at the meeting.
- 15.2 There was a short discussion about how the roles could help and work alongside the NLAF. The NLAF also heard from the Officers about their day to day roles and the practical side of the role.
- 15.3 The NLAF **NOTED** the remit of the new officers who would develop a protocol to permit greater involvement by the NLAF with filtered planning applications involved public rights of way.

17. Events Attended

- 17.1 The NLAF received the annexed report which outlined events attended by members of the Forum.
- 17.2 As a result of members attending these events, the following resolutions were made.

17.3 The NLAF **AGREED**;

- (i) That the NLAF is kept informed by NCC Environment Team of development of the Norfolk 25-year plan for the environment and invited to input to plans where appropriate
- (ii) that the NLAF notes new advances in digital technology that could have a bearing on the business of the Forum.

18. Meetings Forward Plan

- 18.1 The NLAF received the forward plan which suggested items for agendas for the forthcoming meetings.
- 18.2 The NLAF **AGREED** the report.

Activities since the last Norfolk Local Access Forum (NLAF) meeting by the NLAF's three subgroups are summarised.

Executive summary

This report summarises activities since the last NLAF meeting by the NLAF's three subgroups: The Public Rights of Way (PROW) subgroup; the Permissive Access subgroup and the Norfolk Access Improvement Plan (NAIP) subgroup.

Recommendations:

That the NLAF:

- (i) requests an update on the Greenways project at the July meeting as recommended by the PROW subgroup
- (ii) considers a recommendation by the PROW subgroup to send a formal letter to the Legal Orders and Registers Team requesting an update on the Pockthorpe Lane, Thompson case
- (iii) notes the date for the first parish council seminar
- (iv) confirms that the NAIP subgroup has delegated authority to work with NCC officers outside NLAF meetings on the annual delivery plan 2019 / 2020 and monitoring mechanism.
- (v) notes progress with permissive access schemes.

1. Proposal (or options)

1.1. The **PROW subgroup** met on the 11th January 2019 (See **Appendix 1** for minutes from the meeting).

The subgroup recommended that Matt Hayward should be invited back to the NLAF meeting in July to report back on the Greenways project.

The subgroup was concerned about the length of time taken by NCC to send a referral document concerning the Pockthorpe Lane, Thompson case to the Planning Inspectorate for determination and recommended that a formal letter was sent in by the NLAF to Legal Orders and Registers Team requesting an update and timescale.

The first parish council seminar would take place mid week at North Walsham at the Atrium during half term (27th to 31st May 2019) from 2pm to 4pm.

1.2. Permissive Access subgroup

A presentation on the Bradenham permissive scheme which has established 12 km of permissive footpath will be made to the NLAF at this meeting.

PRESENTATION

1.3. **NAIP subgroup**

The NAIP was endorsed by the NCC Environment Development and Transport Committee at their meeting on 8th March 2019 and has been formally adopted by

the Council. It has been uploaded to the NCC website:

https://www.norfolk.gov.uk/out-and-about-in-norfolk/public-rights-of-way/norfolk-access-improvement-plan

NCC would like the NLAF to confirm that it is happy for the NAIP subgroup to have delegated authority to agree the annual delivery plan and monitoring mechanism for 2019/20 outside main NLAF meetings. NCC asks that the subgroup meets in May to do this.

The terms of reference for the subgroup are attached (Appendix 2)

2. Evidence

2.1. Pockthorpe Lane, Thompson is a complex case where access rights are being contested. NCC has made an order for BOAT (Byway Open to All Traffic) for part of the route. The order has attracted landowner objections. The case which is an NCC 'own motion' will be submitted to the Planning Inspectorate for resolution once the paperwork has been approved by NPLAW.

- 1 Introductions and apologies for absence
 - The following were absent from the meeting: Ian Witham and Helen Leith.
- 2 Minutes of the meeting on 7th January 2019 The minutes were approved as a correct record.
- 3 Matters arising from the minutes, not otherwise on the agenda
- 3.1 Re previous minutes 3.1
 - The NAIP had been approved by the Environment, Development and Transport committee on 8th March.
- 3.2 Re previous minutes 4.3. AH updated the meeting on plans to develop a 25 year plan for the environment. The intention is for the plan to be developed jointly with Suffolk CC. Draft plan to be available by December 2019. Plan has split responsibility across 2 areas: baseline information on the environment (to enable gains in biodiversity to be measured) and policy drivers from central and local government. VC asked if landowners were involved - yes, FWAG and NFU are involved There will be another public seminar asking for feedback probably in

December 2019.

Draft to could come back to the NLAF in the summer. **SW to add to** meetings forward plan.

3.3 Any other matters. VC had attended the Fakenham consultation on the Greenways project and felt this project should also report back to the NLAF again.

AH agreed to ask M Hayward to attend the July NLAF.

- LAF Minutes of the meeting on 30th January. The minutes will be 4 circulated shortly.
- 4.1 A joint communications group for NLAF/Pathmakers will be set up – report

to go to NLAF meeting on 3rd April to agree members and terms of reference.

4.2 NLAF recruitment

5 Partnership and Community Working

5.1 Volunteer Co-ordinator role

SA said that a bid had gone into the HLF to develop organisational resilience by Pathmakers but a volunteer co-ordinator role had not yet been identified by Pathmakers.

NC requested an update of Pathmakers' achievements to date. MS said that key things were: the development of a 600m boardwalk at Burgh Castle; disability audits; Community Friends Walks at Marriott's Way; Geovation.

5.2 Vision and ideas group

Will be taken forward at the April NLAF meeting when the new members were present.

5.3 Parish Council seminars

Proposals (circulated) were discussed, including timing and venue. It was agreed that the first seminar (north / east countryside officer patch) would take place from 2 to 4 mid week at North Walsham (Atrium, half term, 27th to 31st May 2019) and would be treated as a learning exercise for the other 2 seminars.

ACTION: SW to book Atrium. KH/ SW to work on fine-tuning for agenda.

5.4 To consider any issues from represented organisations (CPRE, OSS, The Ramblers, U3A).

NC reported that the U3A had noted a great improvement in signage and footpaths in good order and thanked MW and RW.

KB said that the BLAF was due to meet on Wednesday 13th March 2019. AH said that Martin Caplin would be attending from Norfolk Trails to give an update on Weavers Way issues (Reedham, Hardley Flood). KB said it would be helpful to have clarity over responsibility for floodbank maintenance when the BESL flood alleviation programme ends next year. It was believed that the Environment Agency were ceasing cutting on flood banks next year, which would have implications for rights of way along the banks. A question was raised about their no longer protecting river banks, but this was thought to be related to the recent transfer of responsibility of short lengths of inland waters to other bodies, and of no major significance.

MS said he had arranged a visit to the Brettenham BOAT to view Natural England plans for a diversion and would report back.

6 Countryside Access arrangements

6.1 General update

MW / RW had circulated a report ahead of the meeting which included visuals from the Power BI system (visualises information from the CRM defect reporting system). The Mayrise CRM system can directly order work for faults under specific criteria from the contractor saving time and money

('job management system'). It was also noted that Power BI was a standard Microsoft application, potentially enabling people outside NCC to analyse the data. The meeting was impressed with the visuals and the defect journey graphic played during the meeting.

MW was not planning general media release to promote use of CRM at this stage. Nevertheless, MW emphasised that reporting through the online system was very efficient, whereas reports received through other means (eg by phone or through *FixMyStreet*) took considerable additional staff time. VC said that KH had written a piece in the local Ramblers magazine to ask people to use CRM to report issues which was very much welcomed. Under 2.2 of MW's report, KH asked for more details on the numbers of S130/56 legal notices served on NCC (very high levels reported for Norfolk against lower levels elsewhere). MW later sent details through which are as follows: "The data was from IPROW surveys of local authorities. I am not a member so do not have access to them but from what I have been told the information was collated from about 50+ local authorities across the Country with many receiving no notices. The average worked out at 2."

Thanks were expressed to MW and RW for their report.

6.2 <u>Major infrastructure projects</u>

AH said that he had arranged a meeting with David White (who heads the Green Infrastructure Projects team that deals with planning application responses) and Stephen Faulkner to discuss a protocol to engage the NLAF in a timely manner with projects that impact PROW, including the timescales needed for responses to be made.

VC welcomed this: he is concerned that without this, then the NLAF could lose the opportunity to comment. He requested maps of where schemes are, and good narrative to enable the NLAF understand the implications. He felt it was very important to the credibility of the NLAF to enable them to input.

Action: AH to report back on meeting with David White and Stephen Faulkner.

6.3 Online reporting system See 6.1

6.4 Earsham footbridge

AH reported back on progress to date. Bridge removal and replacement will be very expensive but costs will be shared with Suffolk CC. Re-routing the path had been considered but the landowner was not in favour and enforcement (of this option) could fail. He further noted that the design is challenging and access difficult, and thought it would take until summer 2020 to resolve.

6.5 TAMP

The PROW subgroup was disappointed with the response not to review criteria for responses to PROW issues.

6.6 England Coast Path.

Diana Curtis to return to the 3rd April NLAF to update the NLAF on progress.

6.7 Pockthorpe Lane

NC had been in contact with Lawrence Malyon at Legal Orders team (and is on the email list to receive updates on the case directly). He felt that a considerable time had elapsed between the last communication and wanted to know what was happening. NC requested that the NLAF wrote to NCC to find out what the delay is with progressing the case.

SW to ask Legal Orders and Registers Team for an update and to forewarn them that the NLAF may send in a formal letter requesting an update on the case.

6.8 Cley FP4

NC was unhappy that the footpath does not lie on the definitive line on the map (which is on top of the flood defences – a 6 foot high wall). NC was unhappy that the practical route which is in use is along the highway at Cley. MW said the issue was for the Environment Agency to resolve, and it was noted that the Agency had provisionally scheduled work here for the coming financial year.

6.9 Beachamwell

In addressing concerns raised about obstructions on paths in Beachamwell, MW said that landowners had been given incorrect information by NCC and a DMMO was underway to correct the line of the path on the definitive map. KH noted the need to ensure that steps needed to be taken to prevent wrong information being given in any other cases.

6.10 TTRO

Advance notice was requested by MS concerning Temporary Traffic Regulation Orders. MW said that although it would be good for the NLAF to be informed of any necessity to close routes in advance, in practice, it would be too difficult to circulate this to the NLAF in all cases: all TTROs are on the NCC website. Nonetheless, AH agreed to discuss with colleagues whether this could be done in significant cases.

6.11 Any other issues

KB – Honing and Dilham. It was reported that a member of NCC staff had indicated that work would be of low priority as this was a dead end path, but the path in fact provided a route to access land (a common).

AM – Redhill Lane, Watton leading to Bodney Camp. Issues about blockages. **MW to investigate**

7 Claims for lost paths ('2026')

NC expressed concern that there would be inadequate resources (at NCC) to deal with 2026 cases

8 Reports from NCC Officers

MSg reported good recent results through her post and Gemma's, with 2 proposed large developments now including public footpaths. If planning applications affect PROW, NCC will comment on them.

GH and MSg will provide firm information from the highway authority (NCC) to the relevant planning authority.

Meetings due to be set up with planning authorities to ensure they have access to best practice (with respect to PROW) so they can include this in planning responses (includes the Broads Authority)

MSg offered a written report to the next PROW s/g on her activities, which was welcomed.

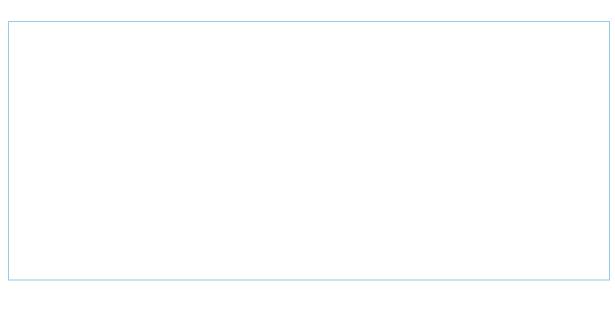

Executive summary

The NLAF agreed at its last meeting (30th January 2019) to set up two working groups (Communications; and Vision and Ideas).

Recommendation:

That the NLAF discusses and agrees terms of reference and membership for the two groups.

1. Proposal (or options)

- 1.1. The NLAF agreed at its last meeting (30th January 2019) to set up two working groups and to agree terms of reference and membership of the two groups at the 3rd April meeting:
 - (i) one to explore how the value to Norfolk of the wider PROW network could be recognised and developed (Vision and Ideas subgroup)
 - (ii) one to work on a joint Pathmakers and NLAF communications plan to ensure that the work of both is better understood and promoted (Communications subgroup)

2. **Evidence**

2.1. Communications subgroup (Pathmakers and NLAF)

At the last NLAF meeting, the trustees of Pathmakers, the charitable wing of the NLAF, reported the need for better promotion of Pathmakers, which they considered could be most effectively achieved by developing a joint communications plan with the NLAF (the plan would cover promotion of both organisations). Although differing in structure (the NLAF is a statutory advisory group whilst Pathmakers as a Charitable Incorporated Organisation is able to undertake a more proactive role) the aims of both are the same: namely, to seek improvements in countryside access in Norfolk.

The trustees proposed:

(i) that a joint communications group is set up to work on a joint Pathmakers/NLAF communications plan that would ensure that the work of the NLAF and Pathmakers is better understood and promoted. The plan will cover joint branding; joint or linked website; linked annual review; joint awareness raising; joint relationship-building with stakeholders.

It was agreed at the January NLAF meeting to set up the subgroup.

Geoff Doggett outlined the steps necessary to develop a joint communications strategy (Appendix 1) to provide the background for discussions.

Visions and Ideas subgroup

The PRoW subgroup identified the need for a Vision and Ideas subgroup at their meeting in January.

The group could draw on data from NCC Environment Team projects such as: Green Pilgrimage; Staying Active and Independent Longer (SAIL); research with UEA on valuing cycling and walking and their benefits to health and for the visitor economy; to help them develop a vision for the PROW network.

Strategic impact

To address the concerns raised by the Local Access Forum with regards to Public Rights of Way Management and delivering the service in an economic and cost effective way.

Executive summary

At the July 2017 Local Access Forum (NLAF), it was agreed that at each future meeting, a summary of the work the Countryside Access Officers and Environment teams would be provided. At the October 2017 NLAF it was agreed that this report should be presented to the PROW sub-group prior to being brought to NLAF.

This paper highlights this work in terms of the volumes of customer queries received and responded to. The paper also highlights other key areas of work.

Recommendations:

That the Local Access Forum note the progress made to date since the Countryside Access Officer posts were introduced.

1. Introduction

1.1. Since 1 April 2017, there is a single point of contact within each Highways Area office being responsible for their local rights of way issues. By having the officer within the Area office they are more "on the ground" and better placed to deal with the operational reactive issues that occur when managing rights of way. They are supported by the wider Highways Area team staff. In addition, the Norfolk Trails team sits within the Environment Service at County Hall and carries out strategic and developmental aspects of developing the countryside access network.

2. Performance

2.1. The information below summarises the performance information available for the complete months since the last report in September 2018.

The new CRM defect reporting system went live 22nd Thursday March 2018. Defect notes are being made visible to the public in the automatic update emails sent when third party defects have been inspected & more status options available on tablets under the 'No Defect' category, as previously reported.

Minor updates continue to be made to CRM to enhance operation and feedback elements.

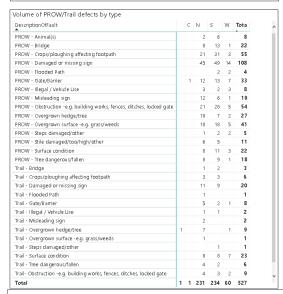
The provision of additional information appears to have led to a decrease in follow up requests.

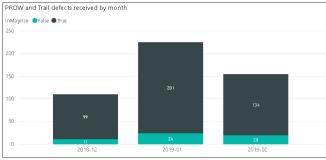

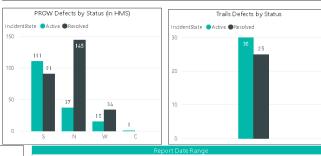


The information presented on this page looks at PROW and Trail defects reports.

Countryside Access Officers (CAOs) receive PROW defect reports on tablets for investigation and in the Customer Relationship Management (CRM) System if the defect is on a trail. CAOs review these and reallocate to the Trails team queue for action if required.

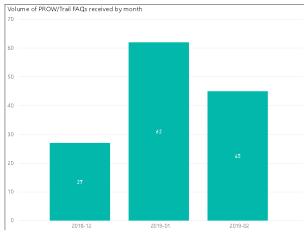

FAQs relate to all enquiries made by customers that include queries on policy, information requests, formal notices and chasing requests. These are logged by the Customer Service Centre and managed within the Customer Relationship Management System (CRM).

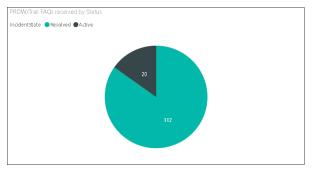
These present to either the PROW 'queue' (managed by Countryside Access Officers) or the Trails queue (managed by environment).

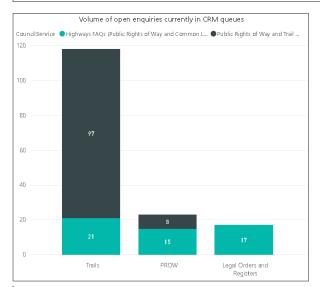

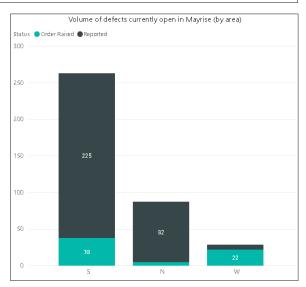


Active Enquiries

This page provides a snapshot of the customer reported defects and FAQs that are currently open in Mayrise and CRM

The graph below reflects what is currently open in the team Queues in CRM. You will notice that some queues have both FAQs and defects. This is because Trails defects are still currently managed within CRM. Defects registered on PROWs will automatically 'leave' CRM and be sent through to Mayrise. You can see the open PROW customer reported defects that are in Mayrise in the graph to the right. Anything with the status 'reported' indicates the defect is awaiting investigation.





In summary:

The Mayrise system of logged complaints had at 28th February, 247 open issues.

The majority of enquiries received continue to be regarding damaged or missing signs, non-reinstatement, obstructions, overgrown surface, overgrown hedges/ trees and surface condition.

The Norfolk Trails Team had at 28th February 2019,128 open CRM issues. The Norfolk Trails Team had at 20th December 2018, 284 open CRM issues. This shows an additional closure rate of over 50%. These reports are often historic and do not relate to current issues which is why a focus is on dealing with current issues which is currently running at over 80% closure rate.

Highways has at 28th February, 28 open CRM issues

These figures do not reflect the substantial volume of reports and correspondence still received through direct email communication from members of the public.

- 2.2. In addition to the numbers above, there have been a number of enforcement notices sent out to landowners since April 2018. The following have been issued:
 - 181 number Section 131A,134-137 Non-reinstatement Notices sent
 - 57 Section 130's (obstructions) and s56 (out of repair) received and issued (enforcement against NCC).

It should be noted that processing these s130/56 legal notices is time consuming for NCC staff. As part of a legal process with set timescales, regardless of priority considerations it has an adverse effect on staff resources. Recent surveys of local authority PROW services indicate that across the country the *average* number of s130/56 notices served on any authority is only approximately 2 per yr.

These issues remain ongoing and being actively monitored and pursued with landowners.

- 2.3. In terms of other progress, key highlights include:
 - Information on the budget including the lengths and frequency of grass cutting was asked to be included in the regular report. In 2017 820 km of PRoW were cut in June and July with a second cut of some of the routes (490 km) completed in September and October. In 2018-19 the initial cut was for 840 km. and the second (partial) cut was just under 500km.
 - CAO's have been reviewing feedback from contractors over the winter and making minor adjustments for 2019 season. Essentially the 2019 programme will run unchanged from 2018 but work will progress towards amalgamation of this and the Trails cutting contract for practical and efficiency purposes by 2020
 - Landowner data from The Rural Payments Agency (RPA) regarding DEFRA grant aid and "cross compliance" requirements is now live and can be used by CAO's along with Land Registry searches to identify the majority of landowners.
 - Money for PRoW capital improvement work schemes has been approved, a total of £200,000 over 2 years. Schemes for 2018/19 totalling £120,000 have been largely completed. Improvement works have been carried out on well used paths in village settings. (E.G. South Walsham FP1 surface improvements are underway: Cromer FP19 surface improvement is in for Easter 2019: Hunstanton FP10 riverside scheme is progressing with a physical route now restored. The route is now being fenced to protect walkers. The footpath will remain closed until the end of April to allow some vegetation regeneration but is hoped to be open for May Bank Holiday 2019)
 - Bids for 2019/20 PRoW capital improvements have been submitted for the remaining £80,000.
 - CAO's are also allocated £15,000 annually for small scale improvements, usually for urban paths, and a small number of surface improvement schemes have been carried out across the County as a result. (E.G. West Winch FP3 well used local route to shops and the school has been widened over February 2019 half term).
 - County Councillors are allocated monies for small scale locally approved highway improvements and some of these have included PROW improvements. (E.G. Widening out of overgrown Restricted Byways within Downham Market.)
 - Highways also operate a Parish Partnership scheme where Parish Councils can co-fund small scale parish highway improvements such as informal trod footways along road verges. PROW improvements are eligible (E.G. Snettisham FP18 path surfacing and bridge replacement due May/June 2019)

Norfolk Trails team Countryside Access arrangements update

Management update:

Significant tree works completed on Marriott's Way at Drayton to allow future surface works to commence

Reactive tree works across the trails network, responding to feedback from users. Continuation of *Chalara* tree management

Engagement:

Discover England project delivered 3 business workshops during the winter at Hunstanton, Cromer and Great Yarmouth.

Coastal Treasures delivered 3 business workshops in the coastal treasures area during February these were at Hunstanton, Snettisham and Thornham Series of 9 engagement events held for recycling the railways project which had an attendance in total of over 450 people

Access improvements:

New signage installed on Cockthorpe circular

New signage installed on Blakeney circular

New town signage installed through Aylsham, Stalham and North Walsham

New signage installed on Bath Hills

New kissing gate installed on Bath Hills
