#### NOTES OF THE MEETING

#### 1. Apologies for Absence

1.1 Fraser Bowe, Ruth Goodall, Paul Baker, Anne Killett, Rebecca Durant, Cllr Maxine Webb, Cllr Lana Hempsall, Chris Allhusen, Kevin Grieve, Sarah Morgan, Niall Pettit, Andrew Darby.

As there were insufficient NLAF members present (7 required, only 6 present), the meeting was not quorate. The Chair confirmed that the meeting would go ahead but that whilst reports brought for information would be received, any agreed NLAF position would need to be confirmed/ decided at the next quorate meeting.

## 2. Chair's Announcements

2.1 Consultations

Consultations that the NLAF had responded to between January 2024 and March 2024 are appended (Appendix 1)

## 3. Minutes

3.1 The minutes of the meeting held on 24<sup>th</sup> January 2024 were confirmed as a true record.

## 4. Declarations of Interest

4.1 There were no interests declared.

## 5. Urgent Business

5.1 There was no urgent business

## 6. Public Question Time

6.1 There were no public questions received.

## 7. Local member Issues / Questions

7.1 There were no member questions received.

## 8. Feedback from Events

8.1 The Vice Chair had not been able to attend the Suffolk LAF meeting in January 2024.

## 9. Meetings Forward Plan

9.1 The NLAF received the report which outlined agenda items for the forthcoming meetings.

Members were encouraged to send further topics for discussion at future meetings to the chair.

## 10. Natural England support for LAFs

- 10.1 The meeting had received a report recommending that the NLAF advises Natural England to hold regular national or regional meetings (online or in person) for LAFs to facilitate greater communication and collaboration between forums, rather than investing further in a SharePoint system. The meeting thought that support for LAFs by Natural England had diminished considerably in recent months and there was agreement with the proposal.
- 10.2 The NLAF **AGREED** (subject to confirmation at the next meeting) that Natural England be advised that NLAF considers it to be a better use of its limited resource to suspend work on SharePoint and instead arrange national (or two or more regional) meetings for LAF members every year or two years. Although in person meetings would have greatest impact, online meetings would be better than none.

The matter would be raised with Regional LAF colleagues at their next meeting in July 2024.

## 11. Norfolk's Local Nature Recovery Strategy (LNRS) – NLAF involvement

- 11.1 The NLAF has been invited to name a representative who will engage with the NCC team developing the Norfolk LNRS to explore opportunities for improved access through nature recovery, to benefit people's health.
- 11.2 Rob Lodge and Martin Sullivan expressed interest in being involved.
- 11.3 The meeting **AGREED** that Rob Lodge and Martin Sullivan would act as interim NLAF representatives for the Norfolk LNRS (arrangement would be formally approved at the next meeting)

## 12. Progress update on the Norfolk Walking, Wheeling and Cycling Strategy and Countywide Local Cycling and Walking Infrastructure Plan (LCWIP)

- 12.1 The report had received a report on progress with the above plans which are set to be adopted by NCC (8<sup>th</sup> April 2024). The plans align with the Norfolk Access Improvement Plan (NAIP which incorporates Norfolk's Rights of Way Improvement Plan <u>www.norfolk.gov.uk/naip</u>), with the LCWIP offering delivery mechanisms for many active travel projects.
- 12.2 A presentation was given by the NCC team attending. See Appendix 2 for presentations given
- 12.3 The draft LCWIP scheme maps and scheme lists had previously been drawn to the attention of the NLAF (they were published in Committee agenda papers (Infrastructure and Development meeting 13<sup>th</sup> March 2024, see page 270 onwards) <u>https://norfolkcc.cmis.uk.com/norfolkcc/CalendarofMeetings/tabid/128/ctl/ViewMeeting</u> <u>Public/mid/496/Meeting/2047/Committee/171/Default.aspx</u>
- 12.4 The NLAF congratulated the team on the very significant work that had gone into engagement and development of the plans. Discussion points raised/ observations included:
  - (i) lack of routes in the northwest of Norfolk. The team explained that there had been no overwhelming evidence of need there.
  - (ii) lack of connectivity between Fakenham and Dereham in the centre of the county.
  - (iii) Improving safe local transport across rural areas (i.e. in areas outside towns which have infrastructure/ investment plans). Wayfinding and cycle parking and integration with other public transport would help.
  - (iv) How postcode data supported the routes developed.
  - (v) Early measurements of progress/outcomes.
  - (vi) Funding for implementing proposals. The Chair of Pathmakers confirmed that the charity would like to assist with funding proposals where feasible.
- 12.5 The NLAF **NOTED** the update.

## 13. NLAF subgroups' report (PRoW; NAIP; Vision and Ideas)

- 13.1 The Chair of NLAF received the reports which set out the latest discussions and recommendations of the sub-groups of the NLAF.
- 13.2 The PRoW subgroup had discussed the involvement of local parishes with PRoW maintenance and had concluded that in areas where there is enthusiasm to do so, better results could be achieved than relying on NCC to do this. However, a wholesale move to that approach was not feasible as most parishes were not able to offer this commitment: management responsibility should remain with NCC across the piece.
- 13.3 NLAF recommendations regarding the Transport Asset Management Plan (TAMP) (regarding a change in priorities for maintenance) could not be agreed as the meeting was not quorate. The proposals would be agreed at the July NLAF meeting (or by correspondence) to enable the NLAF's agreed position to be put to NCC within the time framework for the TAMP review.

The NCC Protected Landscapes Manager agreed with the NLAF's proposals regarding changes to the TAMP and said these would be reflected in her team's Norfolk Trails Management Plan.

13.4 The NLAF regretted proposed changes to the Norfolk Record Office (NRO) opening hours and restriction on the number of items which could be pre-ordered to view.

The recommendations which would be agreed at the next quorate NLAF meeting were that the NLAF should advise the NRO that it:

- (i) Regrets the proposed changes;
- (ii) Expresses the hope that the changes would be temporary and reversible
- (iii) Suggests that the NRO explores the use of volunteers to maintain and extend opening times
- 13.5 The Vision and Ideas Subgroup had also met with useful discussions ensuing on two reports brought to the NLAF by NCC (the Countryside Access Arrangements report and Major Infrastructure Projects and Planning reports). Although not discussed at the meeting, proposals had been shared with NCC, with the full expectation that there would be good alignment with the information sought by the NLAF and what was provided in future reports.

NLAF members present at the meeting stressed how important they felt it was to get the information sought with minimum call on NCC staff resources.

13.6 Points indicated in 13.3, 13.4 and 13.5 would be **AGREED** at the next quorate meeting

## 14. Broads Local Access Forum (BLAF) update

- 14.1 The Chair of the BLAF was pleased to attend the meeting and thanked the Chair and Vice Chair of the NLAF for regular attendance at BLAF meetings.
- 14.2 The BLAF has been concerned with increasing sewage pollution in the Broads: many of the recreation opportunities involve contact with water. There is insufficient recording of faecal indicators although a UEA science team was making measurements in the Wensum catchment.

- 14.3 The Broads Society was developing a countryside code for the Broads to improve awareness and understanding of various user groups' needs.
- 14.4 The Broads Integrated Access Strategy was in its final draft, covering staithes, moorings and navigation issues.
- 14.5 Recruitment of members to the BLAF would be conducted in April and May. Meetings are often off site in village halls around Norfolk the next one was due to take place in Bungay.
- 14.6 The NLAF **NOTED** the updates.

## 15. Pathmakers Projects

15.1 The NLAF received a report from the Pathmakers chair.

The charity was preparing for the 2025 Walk Norfolk in October, with one walk planned for each day of the month. This year's festival would be the last year funded by the HLF and Pathmakers was therefore hoping to attract sponsorship to maintain the festival.

The Pathmakers Chair has been invited to join an NCC steering group working on permissive footpaths, with the expectation that Pathmakers would assist with organising the funds available to landowners for NCC.

15.2 The NLAF **NOTED** the report.

## 16. Appointments to Pathmakers

NLAF appointments to Pathmakers of Sarah Abercrombie, Simon Fowler, Kate MacKenzie, Martin Sullivan and John Jones were agreed for a term of 3 years by NLAF members present (approval would be made at the next quorate NLAF meeting).

Appointments would be **APPROVED** at the next quorate meeting

## 17. Countryside Access Arrangements update

- 17.1 The Forum received the report which highlighted work to manage the countryside access network in Norfolk work (across Highways, Greenways and Norfolk Trails teams).
- 17.2 A presentation was given by the Lead Officer for Placemaking in the Protected Landscapes Team (Appendix 3) which covered progress to improve reporting into NLAF / other initiatives from PRoW and Trails. This included a resume of NCC systems, defects reported, defects resolved, outstanding defects, staff resource history and analyses in progress.

The intention is to provide the NLAF with a one page summary graphic for each meeting to enable them to quickly see trends (initially just for Norfolk Trails – but with the expectation it will also be provided for PRoW down the line – possibly in a slightly different format - will help with Norfolk Access Improvement Plan reporting). Coupled with counter data (footfall) it could help pinpoint where extra resourcing is required.

- 17.3 The NLAF found the presentation illuminating. Questions / observations
  - (i) There was a strong correlation between staff resources available and time taken to resolve defects for Norfolk Trails
  - (ii) Could the distribution of ages of outstanding issues be added to the average age proposed to be included in the analyses?
  - (iii) Could the analysis cover geographical data for the Broads (so that it is possible to see where defects have been resolved in the Broads area – the answer was probably but just for Norfolk Trails )
- 17.4 Norfolk Trails are hoping to develop a stand alone website, which would use GPX information, and could potentially include heat maps of defects reported.
- 17.5 Historic defects on Norfolk Trails that require resolution would be dealt with as a priority (clear the backlog).
- 17.6 The NLAF **NOTED** the report and thanked officers for their time preparing it but remains concerned that the significant backlog of issues reported to NLAF over recent years is not reducing and again seeks the views of the County Council on ways of addressing this.

## 18. Major Infrastructure Projects and Planning

- 18.1 The Forum received the annexed report which updated them on the major infrastructure projects that were currently underway in the County which impacted on Public Rights of Way. Latest information on each of the schemes was highlighted in the report
- 18.2 The NLAF **NOTED** the table of major infrastructure projects in Norfolk

Martin Sullivan said that he did not intend to stand as Chair again in October. The Forum thanked him for all his commitment, dedication and time to its work over so many years which had contributed to the much higher profile of countryside access now seen across Norfolk in recent years.

The next meeting is scheduled for Wednesday 3<sup>rd</sup> July 2024 at 10am at County Hall (or off site).

1	Introductions and apologies for absence All attending (online or in person) were welcomed and thanked for attending. It was noted that former subgroup members Paul Baker and Ruth Goodall had resigned from NLAF, and Birgit Griem has resigned from this subgroup.

4.1	<ul> <li>4.1 <u>Norfolk Record Office opening hours</u>: NLAF had not been able formally to consider the recommendation that NLAF respond <ul> <li>to regret these proposed changes;</li> <li>to express the hope that they would be temporary and reversible; and</li> <li>to suggest that NRO explore the possible use of volunteers to enable opening hours to be maintained and extended.</li> </ul> </li> </ul>	Ken
4.2	<ul> <li>4.2 <u>East of England Coast Partnership</u> (formerly East Anglia Coast Path): an update was given in the Countryside Access Arrangements report (item 6)</li> </ul>	
4.3	4.3 <u>The Great Chalk Way</u> : an update was received from Katy Owen. The Great Chalk Way committee (made up of a group of volunteers) is planning to launch the route in September 2024. The committee has produced interpretation boards to mark the trail and asked for these to be installed at the start and end of the Peddars Way National Trail. Unfortunately, these boards were developed without consideration of accessibility requirements and we are not able to support them in their current format. We offered to provide assistance in this matter, which was declined by the committee. We understand that the committee is now working with private landowners to secure installation of the two boards. We are supporting this project digitally (via weblinks) as a means of

4.4	4.5 <u>Report statistics</u> : It was assumed that issues about reported statistics will be addressed in the planned changes to the report format currently used for Countryside Access Arrangements.	
5	Partnership and Community Working	
	<u>Issues from represented organisations</u> : Ian Mitchell reported that the enquiry into Thompson FP1 had resulted in NCC downgrading its order from a BOAT to a Footpath. One objector maintained their objection to this and had requested that the matter be decided by public inquiry rather than through written representations. A decision by PINS was awaited.	
6	Countryside Access Arrangements report	
6.1	<u>General update</u> : A report was received, welcomed and considered. It was noted that Helen Terry had been appointed as Chair of National Trail Coast Path Forum, which engages all the National Trails along the coastline of England and Wales and brings 'a voice for the coast' to the National Trails UK Advisory Council. She was congratulated on this appointment.	
	Ken had raised a number of questions and comments before the meeting; a written response had been made to these but had not arrived in time to be considered by the meeting. Further issues were identified during the meeting.	
	1 <b>Report</b> 2.4 - " persistent use of other reporting systems is leading to the loss of data and requiring significant additional administration" <b>Question</b> The provision of reporting systems is in the hands of NCC, so presumably it can change or remove inefficient systems, as long as it leaves viable means of reporting to anyone whatever their circumstances. Can it be explained how loss of data occurs and whether this can be prevented by changes in the reporting systems? <b>Response</b> The reporting system that NCC uses and promotes is the most efficient way of getting enquiries through to the appropriate officer. The use of third party (not NCC provided or endorsed) systems, such as Fix My Street, is not compatible with NCC systems and can lead to double or triple handling of data during the transfer to the NCC system, allowing for the introduction of error as data is transcribed; and loss of data, particularly photographic records. A more efficient system does not require changes in the NCC reporting system, only to encourage users to use it; and reiterate that the use of third party systems is having a negative impact on the provision of the service by diverting resource away from the front line.

routes on the network would not require cutting, if they have hardened surfaces for example. NCC does not have a full asset inventory of PROW including what length of path "requires" cutting in order to compare with the length of path actually covered by the cutting contracts.

- 3 **Report** 2.11, 5th bullet **Question** It is disappointing to see there is still no progress regarding the obstruction at Upwell. Can it be indicated what sort of issues are preventing progress? **Response** none
- 4 Report 2.11, 7th bullet "Most landowners respond to reinstatement notices …" Question Can some statistics be provided here maybe for the revised reporting system currently under development? Response The notices sent out by NCC do generate an element of responses from affected landowners. Many respond to state that work has been carried out, others may do the work but do not notify NCC. Accurate statistics to provide the percentage compliance would require compliance visit(s) to each and every site that has been the subject of a served notice, but we do not have the resource to do this. Instead we carry out a small number of selected compliance visits, but to a large extent rely on landowners who take the trouble to respond as being true to their word.
- 5 Report 2.11, 8th bullet "The £15k "Urban paths" allocation has a shortlist of sites considered for funding for the next 2 to 3 years ..."
   Question in the meeting What are 'urban paths'? Response in the meeting was to suggest to whom this question might be directed.
- 6 Report 2.11, final bullet Question "NCC has recently been rated as No1 (against comparable authorities) in the National Highways and Transportation Survey for customer satisfaction regarding public rights of way." This assertion was made 6 months ago, but I have been unable to find anything among the publicly available information and a request for evidence has not been replied to. Can the source for this assertion be provided? *Response none*
- 7 Report 3.3 Question The link provided here does not work and my understanding is that the TAMP is no longer made publicly available except by request. Can it be stated why this is no longer easily accessible? Response following the meeting A copy of the TAMP has been supplied. It had been removed from the website as "The TAMP does not meet necessary accessibility criteria for use by those with screen-readers etc, so is no longer allowed to be available as a download on the NCC website." (See also 6.2.3 below.)
- 8 Ian Mitchell had compared numbers of issues arising from 5 major causes (damaged or missing sign, overgrown surface, overgrown hedge/tree, obstructions and crops/ploughing) for the two year periods June 2020-22 and June 2022-24. The results are presented in the attached table. This gave rise to discussion about why the increases and decreases might be as they are, accepting that it was difficult to discern a clear overall pattern of change.

#### 6.2 Specific issues

- 1 King Charles III England Coast Path: Katy Owen reported that the route change through Great Yarmouth following opening of the new crossing had been discussed with Natural England. It is something we are keen to deliver and will seek to submit a variation request in due course, however it is not a priority for us at the moment. We are currently experiencing a high volume of issues/paperwork linked to erosion along the coast, which we must prioritise at this time.
- 2 *Peddars' Way crossing at Swaffham:* National Highways had indicated that this was an issue for a future programme of work, timescale as yet unknown.
- 3 *Transport Asset Management Plan (TAMP)*: NLAF had not been able to agree recommendations regarding a change in priorities for maintenance as the meeting was not quorate. The proposals would

## **Executive Summary / Introduction from Cabinet Member**

The Greenways Project Team is carrying out a mid-point review on the Norfolk Access Improvement Plan (NAIP) 2019–2029, following feedback from the Norfolk Local Access Forum (NLAF) in Autumn 2023. To date work has included the collation of information from various sources to assess progress against the 2029 targets. The next stage for the NAIP mid-point review will involve holding a set of workshops with NCC officers and NLAF members. The aim of these workshops will be to co-develop a new model for the NAIP monitoring report process. The ambition is to implement a more effective reporting process with key performance indicators which offer streamlined and rigorous data collection and evidencing. This new model will be presented to the NLAF at the October 2024 meeting for approval.

## **Recommendations:**

1. NLAF approves the proposal to hold/participate in workshops with NCC Officers to co-develop a new reporting process for the NAIP.

## 1. Background and Purpose

1.1 The Greenways Project Team (Environment Service) was asked to carry out a mid-point review on the NAIP. Monitoring reports are collated for the NAIP each year. The NLAF requested that key performance indicators such as easily understandable metrics and data should be included in future reports. We are currently halfway through the 10-year lifespan of the current NAIP and it is therefore an appropriate time to review the reporting process.

## 2. Proposal

- 2.1 To update the NAIP reporting process to be more streamlined and rigorous, as part of the 2023-24 mid-point review. Reports are collated and submitted to the NLAF each October, as part of the annual NAIP's delivery plan. The NAIP is a statutory document. As such, the mid-point review focuses on improvements to the NAIP's internal reporting structures. It will not trigger a full review of this plan.
- 2.2 NCC Officers will be invited to support this review, as will members of the NLAF and any other stakeholders deemed relevant.
- 2.3 Both NCC Officers and NLAF members will contribute to this process through participation in max. 3 workshops.
- 2.4 The new reporting model will be presented to the October 2024 NLAF meeting for approval.

## 3. Impact of the Proposal

- 3.1 Support the NAIP reporting process to be more efficient, effective, and robust.
- 3.2 Provide key performance indicators that track success and performance over time.



## Executive Summary / Introduction from Cabinet Member

At the July 2017 Local Access Forum (NLAF), it was agreed that at each future meeting, a summary of the work the Countryside Access Officers and Environment teams would be provided. At the October 2017 NLAF it was agreed that this report should be presented to the PROW sub-group prior to being brought to NLAF.

This paper highlights this work in terms of the volumes of customer queries received and responded to. The paper also highlights other key areas of work.

## **Recommendation:**

1. That the Norfolk Local Access Forum notes the progress made to date since the Countryside Access Officer posts were introduced.

## 1. Background and Purpose

1.1 Since 1 April 2017, there is a single point of contact within each Highways Area office being responsible for their local rights of way issues. By having the officer within the Area office, they are more "on the ground" and better placed to deal with the operational reactive issues that occur when managing rights of way. In addition, the Norfolk Trails team sits within the Environment Service at County Hall and carries out strategic and developmental aspects of developing the countryside access network.

## 2. Proposal

- 2.1 The information in **Appendix 1** summarises the performance information available for the complete months since the last report.
- 2.2 The CRM defect reporting system went live in March 2018. Defect notes are being made visible to the public in the automatic update emails sent when third party defects have been inspected & more status options available on tablets under the 'No Defect' category, as previously reported.

Use of the NCC system is the most efficient way of reporting issues, Other systems require additional administration which puts additional strain on limited staff resources.

Minor updates continue to be made to CRM to enhance operation and feedback elements.

## 2.3 A new report has been prepared to display the relevant PROW/Trails information via PowerBI Appendix 1 (a) Stats for the last 3 months and Appendix 1 (b) Stats for the last 2 years.

- 2.4 In summary, the Mayrise system of logged requests for service on 5<sup>th</sup> June 2024 had 1,682 open issues for Public Rights of Way (up 142 comparable with the last quarter figures). The fact that overall numbers remain high reflects that PROW issues are often complicated matters to resolve. Most enquiries received continue to be regarding damaged or missing signs, non-reinstatement, obstructions, overgrown surface, overgrown hedges/ trees and surface condition. Vigorous vegetation growth has led to an increase in enquiries about surface maintenance. With regard to Section 2.2 above, exacerbating this issue is that NCC continues to receive, from one source, a high volume of enquiries regarding PRoW issues, some of which were considered disparaging and aggressive, and also persistent use of other reporting systems which is leading to the loss of data and requiring significant additional administration. This is diverting the limited resources away from the priorities of the service.
- 2.5 The original rise in cases is primarily attributed to the impact of Covid 19. While the country went into lockdown Central Government advice was that local outdoor exercise was promoted for wellbeing and there was evidence of significant increases in walking, running and cycling on village/local path networks across the Country. There were also isolated cases of landowners using Covid as an excuse to close some paths. Naturally, additional use has led to an increase in complaints about the condition of the local path network. There remain considerable backlogs to work through. This has been recognised within the ROW profession nationally and some LAs are now re-evaluating the importance of adequately maintaining local path networks and several Eastern Region Highway Authorities have recently reported increases in staff numbers and maintenance budgets in order to manage the demand. Anecdotal evidence suggests that the increased use of local networks continues with people having formed new habits of getting outdoor exercise. There is no shortage of evidence relating to the importance of how local path networks contribute to health and wellbeing.
- 2.6 At the current time there are no additional financial resources earmarked for PROW maintenance. 3 x PROW Technicians have commenced their roles in mid-September 2021, one each in support of Countryside Access Officer for the three highway areas in an attempt to tackle some of the backlog of open issues. The contracts have now been extended to March 2025.

2.7 Overall, the number of unresolved public enquiries through the CRM system is remaining up slightly from the last quarter. As of the 5<sup>th</sup> June 2024, the Norfolk Trails Team had 219 open CRM issues (up 20)

PROW had 188 open CRM issues, (up 7)

- 2.8 These figures do not reflect the substantial volume of reports and correspondence still received through direct email and telephone communication from members of the public, but which remain unrecorded. Neither does it reflect the complexity often found in resolving PROW issues.
- 2.9 In addition to the numbers above, there have been a number of enforcement notices sent out to landowners since April 2024. The figures include more informal email conversations where the landowner is politely reminded that enforcement may follow if action is not forthcoming. The following have been issued:
  - 64 Section 131A,134-137 Non-reinstatement Notices/emails issued. The majority are resolved without recourse to further enforcement. It should be noted that there are significant resource pressures associated with serving and following up on Notices.
  - Since April 2024, 7 Section 130's (obstructions) or s56 (out of repair) notices have been received by NCC. These are legal notices served against NCC.
- 2.10 It should be noted that processing any legal notices is time consuming for NCC staff. Similarly, when NCC receives FOI requests, these are a drain on limited staff resources.
- 2.11 In terms of other progress, key highlights include:
  - Higher incidences of people using local paths during Covid and anecdotal evidence that this has continued since. The wet winter 20/21 saw an increase in flooding reports and associated bridge damage. These issues are still being worked through and there have been further instances of issues caused by the wet winter of 2023/4. Bridges Team have a substantial backlog of missing structures, with most of the structures being timber there is a constant requirement to replace on a cyclic basis. Approximately 20 larger scale structures were replaced on the network each financial year.
  - Smaller scale bridges/ligger crossings remain a Highway Area responsibility and are also subject to continual cyclic replacement.
  - 2024 cutting: The 2024 season commenced with cutting from early may which continues and nears the end of the first cut ( of 2 for PROW and 3 for Trails)
  - Some Parishes have expressed an interest in carrying out their own cutting with financial support from NCC (equivalent to the amount spent under the main contracts) but to date this only currently applies to a handful of parishes.
  - Enforcement procedures were carried out on a path at Upwell in 2021 but the path is again obstructed. The matter is now with NPLaw regarding potential court action. June 2024 update: No further progress has been made. Several longstanding obstruction cases remain ongoing. A growing number of encroachment cases are under investigation.
  - In 2023 PROW staff attended an "enforcement" course run by the Institute of Public Rights of Way(IPROW). As a result the CAO's will be compiling some procedures for PROW to complement NCC's overarching enforcement protocols drawn up by Trading Standards and others, to ensure a consistent approach across the Council.

- Not all 'enforcement' relies on more formal action. It might be more appropriately be termed as "compliance". Most landowners respond to reinstatement notices and there continues to be dialogue with most landowners leading to small scale improvements that are nevertheless essential to the integrity of the network. A landowner at Wiggenhall proposes to bequeath a replacement bridge on a favourite walk. This is due for completion by the end of June 2024
- The £15k "Urban paths" allocation has a shortlist of sites considered for funding for the next 2 to 3 years assuming this funding stream remains available. Two schemes were completed in 2023. Prices for the work have risen significantly but the overall budget for such works has remained static. Discussions are ongoing with a Parish Council regarding a scheme in South area for 2024.
- County Councillors have "Member Fund" to allocate to local Highway projects each year, increased to £11k each for 2023/24 and this can be spent on small scale PROW projects of maintenance or improvement. To date, uptake on tackling PROW issues has been limited. Several potential schemes have been suggested by PROW staff.
- NCC has recently been rated as No1 (against comparable authorities) in the National Highways and Transportation Survey for customer satisfaction regarding public rights of way.

### 2.12 Norfolk and National Trails

Updates on work taking place over the last quarter are outlined below.

### 2.13 National Trails: Peddars Way & Norfolk Coast Path

#### East of England Coast Partnership (formerly East Anglia Coast Path) update:

Partnership talks were recently led by Suffolk County Council. Motion to co-finance an Officer put forward and supported by all partners in principle. Greater clarity/agreement on financial implications and intentions of Partnership formation is required before Norfolk County Council can commit funds. There have been no further communications or meetings since Dec 2023.

**Brancaster boardwalk:** The Brancaster Boardwalk has been completed and is open to the public. Feedback to date has been excellent. A launch event scheduled for 7 June has been postponed to later in the year, as Norfolk County Council is now in the pre-election period. Our intention is to now celebrate this more formally early autumn with activities at Brancaster, to engage with new audiences.



**Norfolk Coast Path developments:** 'Stretch 3' of the Norfolk Coast Path (part of the King Charles III England Coast Path, between Hunstanton to Weybourne) is still with the planning inspectorate. We currently have no date but conversation is ongoing between Natural England and the inspectorate, indicating it is progressing.

**Maintenance at Beeston Bump, Sheringham:** Repair works at Beeston Bump are a priority. We are currently waiting for permission/consent from NNDC and Natural England.

**Coastal erosion:** Variation reports are underway at Sidestrand and Happisburgh locations, linked to severe coastal erosion. This is a priority work area for the team and is currently absorbing a lot of resource.

**Interpretation:** New interpretation is underway for the newly opened Stretch 4 of the Coast Path, between Hunstanton and Sutton Bridge. Signs have been designed to be aligned with our Protected Landscapes new branding and use mixed/tactile materials to engage with wider range of users. The signs at each location will be slightly different to fit in with the location, and to retain attention.



**Additional interpretation for 'Stretch 3':** A funding bid (£43,100) has been submitted to Farming in Protected Landscapes (FiPL) for enhanced interpretation further along the National Trail. There is a panel meeting on 10 June to award funding.

**Engagement through guided walks:** We are collaborating with the Youth Hostel Association (YHA) on developing guided walks, with the ambition being to align with Pathmakers/walking festival and the Norfolk Coast Dark Skies Festival. This is part of a national programme of events and helps us introduce the Coast Path to a new audience.

**Engagement through the NTUK Summit:** National Trail Team attended the NTUK summit in Cheltenham. Helen Terry was invited to present the Brancaster Boardwalk project as an example of best practice.

**National Trails Coast Path Forum:** Helen Terry has been appointed as Chair of National Trail Coast Path Forum. This forum engages all the National Trails along the coastline of England and Wales and brings 'a voice for the coast' to the National Trails UK Advisory Council.

**National Trail Partnership:** Work continues on revitalising the National Partnership, and the team had a meeting with Cllr Andrew Jamieson, Chair of the Partnership and Deputy Leader of the Council to discuss this on 7 June 2024. We will be updating the Partnership's Terms of Reference, Mission and Vision and reviewing membership of the Partnership. The first meeting expected end of August/beginning of September 2024.

**Cutting Contract Tender:** One of the most prominent issues on the Trails network is vegetation growth, which means the cutting contract is an important part of the maintenance schedule. This is the framework for the National Trails, Norfolk Trails and the Public Rights of Way teams. The contract was up for re-tender this year and Benjiman Grapes in the National Trail team has been leading on changes to ensure the contractors work effectively and can manage a sustainable area. We have now appointed our contractors this year and will be monitoring their progress. However, it will remain a challenge to keep abreast of the growth due to the recent weather conditions.

#### 2.14 Norfolk Trails

**Recruitment:** Recruitment of Norfolk Trails team leader and additional Norfolk Trails Maintenance Officer is approved and underway. This will provide valuable assistance to Martin Caplin and Jason Smyth in maintaining the promoted Norfolk Trails network. This recruitment will represent a significant increase in staffing levels, bringing the number of Norfolk Trail officers to four.


**Wherryman's Way Circular Walks:** As part of the Community Infrastructure Levy (GP51) Wherryman's Way Circular Walks Improvements Project, the Norfolk Trails team have completed the required outputs, improving access and making the routes viable for more users. In the last three months they have:

- Improved four circular walks with bi-directional signage throughout and waymarking
- Improved access including replacing squeeze gates with wide-berth kissing gates
- Improved bridge width and included handrails and access ramps
- Added seating



### 3. Clarification of Timescales re issue reporting

- 3.1 The NLAF requested clarification of the issue reporting process which is presented below:
- 3.2 If an issue is reported online this will be allocated to the tablet of the responsible Countryside Access Officer/ Trail Officer for review almost straight away. If there is a danger to life, we advise customers to call in and our

colleagues in the customer service centre would alert the local team so that they can take remedial action within 2 hours. If a report is made by fixmystreet or by email, there will be a delay as these have to be manually added to the system (usually one working day)

- 3.3 Officers will assign a priority to each defect reported based upon a risk assessment. Our Countryside Access Officers will prioritise enquiries as per the TAMP):
  - 9.1.1.1.7. Public Rights of Way
  - 9.1.1.1.7.1. Work programmes are based on a risk assessment of the severity of the problem and the likelihood of its affecting others. Issue logged for attention as follows:
    - High if it affects a nationally, or regionally, promoted route
    - Medium if it affects a well-connected or well used path
    - Low if it affects only an isolated generally unused path or one that runs alongside another path. Those deemed a low priority will be actioned when resources are available.

The risk register helps officers determine the priority. The timescales of which are below.

(i) If the defect is not deemed an emergency and is on a trail, it is allocated to a Trails Officer to investigate, prioritise and action based upon the resources available.

(ii) If an issue has already been reported, this should be visible on the online map so the customer knows that this has already been identified. The customer who reported the issue will get an email update after investigation to advise if this is a duplicate (where we have identified the issue already and it is in the system); if we are sending out a letter to landowners; or if we have identified work is required. If it has been identified that work is needed and a customer has not had a response in over 6 weeks, our customer service colleague will look to see the status of the defect and assign to the relevant officer to provide an update.






