In October 2019, the Council facilitated a number of initiatives and highway improvements to reduce the likelihood and severity of accidents along the C470 Dereham Road, Scarning.

In June 2020, the Council promoted a Traffic Regulation Order (TRO) to amend the speed restrictions at this location.

Prior to formally advertising the TRO, statutory consultees were consulted on the proposals. The consultees included the local County Councillor, Scarning Parish Council and emergency services who all supported the proposals.

Formal consultation, including public notices in the local newspaper and on site was carried out on 2<sup>nd</sup> October 2020.

## **Executive Summary/Introduction from Cabinet Member**

In October 2019, following an accident investigation study, the Council was requested to promote a number of initiatives to reduce the likelihood and severity of accidents along the C470 Dereham Road, Scarning. This included proposals to reduce speed limits.

There have been three fatal accidents in the last 20 years in this section of the C470. Road safety improvements have been implemented on site previously. In June 2020, the Council promoted a Traffic Regulation Order (TRO) to amend the speed restrictions at this location to further improve road safety.

#### Recommendation

To implement the speed limit changes as detailed in Appendix A & B.

## 1. Background and Purpose

1.1 The C470 in Scarning has a poor accident record, including three fatalities over the past 20 years. In June 2020, to help improve safety as recommended by the accident investigation study, the Council promoted a Traffic Regulation Order (TRO) to reduce the speed limit on the area of road detailed in Appendix A & B.

Prior to formally advertising the TRO, statutory consultees were consulted on the proposals. The consultees included the local County Councillor, Scarning Parish Council and emergency services who all supported the proposal.

Norfolk Constabulary recommended extending the proposed 50mph section up to the junction with A47 and this was included with the TRO.

As part of the formal consultation process, notices were published in the local newspaper and notices on site was carried out on 2<sup>nd</sup> October 2020 (see Appendix A).

## 2. Proposals

2.1. The proposal seeks to implement new speed restrictions on C470 Dereham Road, reducing approach speeds to bends on the C470 which have seen disproportionate numbers and severity of accidents.

See Appendix B for the proposed TRO layout plan.

## 3. Impact of the Proposal

3.1. The advertisement received two objections which are summarised below.

There is no reason why a competent driver cannot drive in a sensible manner within the existing limits. Reducing the speed limit from 50mph to 40mph is unnecessary as there are few frontages, it also raises the risk of noncompliance. Police are also unlikely to enforce.	N	I am confident that a lower speed limit will improve road safety on this section of road and reduce the likelihood of loss of control incidents. With regard to the three fatal accidents which occurred here I can confirm that the none of the accident records, provided by Norfolk Constabulary, cite alcohol or defective vehicle as contributory factors. All three accidents involved single vehicle loss of control on a right-hand bend travelling from east to west. Two occurred in dark conditions (hence the improved verge markers we are installing to improve night time driver guidance) and two involved vehicles colliding with roadside trees (hence the verge clearance). Nevertheless, reducing the operating speed of the approach to the bend will reduce the likelihood of drivers losing control in the first place and is a key part of the package of measures. Would prefer to see a 40mph limit set across the whole stretch of C470, to aid cyclists.	N	Engineer).  The C470 between Scarning (Dereham) and Scarning village has a detached footway and light frontage development over its central section. It therefore complies with our guidance for a 50mph speed limit. There is no evidence or signals to drivers that an unusually high level of cycling need is present. The road environment is quite different to the more dense frontage development present at the existing Scarning 40mph speed limits. Consequently, drivers would not understand the need to travel at 40mph in between Scarning (Dereham) and Scarning village and speed limit compliance would be poor. I would also be concerned that having 40mph throughout would weaken the existing 40mph speed limits through Scarning village and Scarning (Dereham) and give rise

to higher traffic speeds in those areas. I am therefore unable to support this request.

4.1. The recommended proposal should be supported as this scheme will directly address the issues raised in the accident investigation report, by implementing a reduced speed limit to improve road safety.

# THE NORFOLK COUNTY COUNCIL (SCARNING, C470 MAIN ROAD/SWAFFHAM ROAD) (40MPH AND 50 MPH SPEED LIMIT) ORDER 2020

The Norfolk County Council proposes to make an Order under the Road Traffic Regulation Act, 1984, the effect of which will be to prohibit any vehicle from exceeding the speeds specified below as follows-

- (1) 40 miles per hour along the length of the C470 Main Road/Swaffham Road set out in Schedule 1 below; and
- (2) 50 miles per hour along the length of the C470 Swaffham Road as set out in Schedule 2 below.

Please note this proposed Order is being re-advertised due to an extension of 137m to the 40mph speed restriction to start at the junction with the A47 being considered as a result of the previous consultation.


